REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Gaslamp Cinco de Mayo

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: 5th Avenue, Island Avenue, William Health Davis Park

PROJECT DESCRIPTION: Special Event Permit for a Cinco de Mayo celebration event that would include the temporary use of a low rider car show, fenced in beer garden, a stage, entertainment, fencing and/or barriers, onsite food preparation, food vendors, food trucks, tents/canopies, generator, tables, chairs, portable restrooms, and recycle/trash containers, to occur in the Gaslamp on 5th Avenue between G Street and Island Avenue, and on Island Avenue between 4th Avenue and 6th Avenue on May 3, 2025. The beer garden would take place at the William Health Davis Park from 12 PM until 7:30 PM. There would be a stage with entertainment and sound amplification would occur from 8 AM until 8 PM. Noise associated with the event activities and set-up/ dismantling would occur from 6 AM on May 3, 2025, until 6 AM on May 4, 2025. On May 3, 2025, set-up would occur from 6 AM until 12 PM, the event would occur from 12 PM until 8 PM. Dismantling would occur from 8 PM on May 3, 2025, until 6 AM on May 4, 2025.

Road and parking closures would be associated with the event and would occur from 6 AM on May 3, 2025, until 5 AM on May 4, 2025, and would include 5th Avenue between G Street and Market, and 5th Avenue between Island and Market, Island between 4th & 6th Avenue, and 5th Avenue between G and F Streets.

Production Parking:

7th Avenue between Island and Market on the west side, 5th Avenue between G and Market, 5th Avenue between Island and Market, Island between 4th & 6th Avenue, and 5th Avenue between F and G Streets.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego

conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

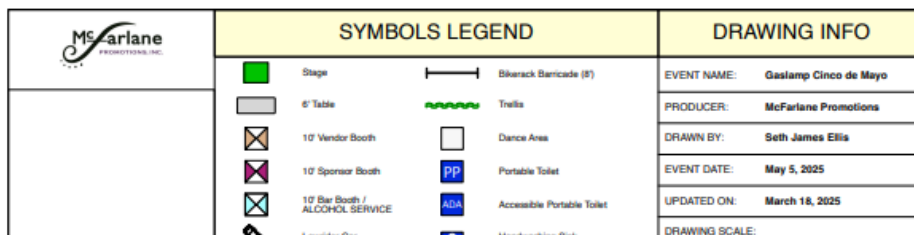

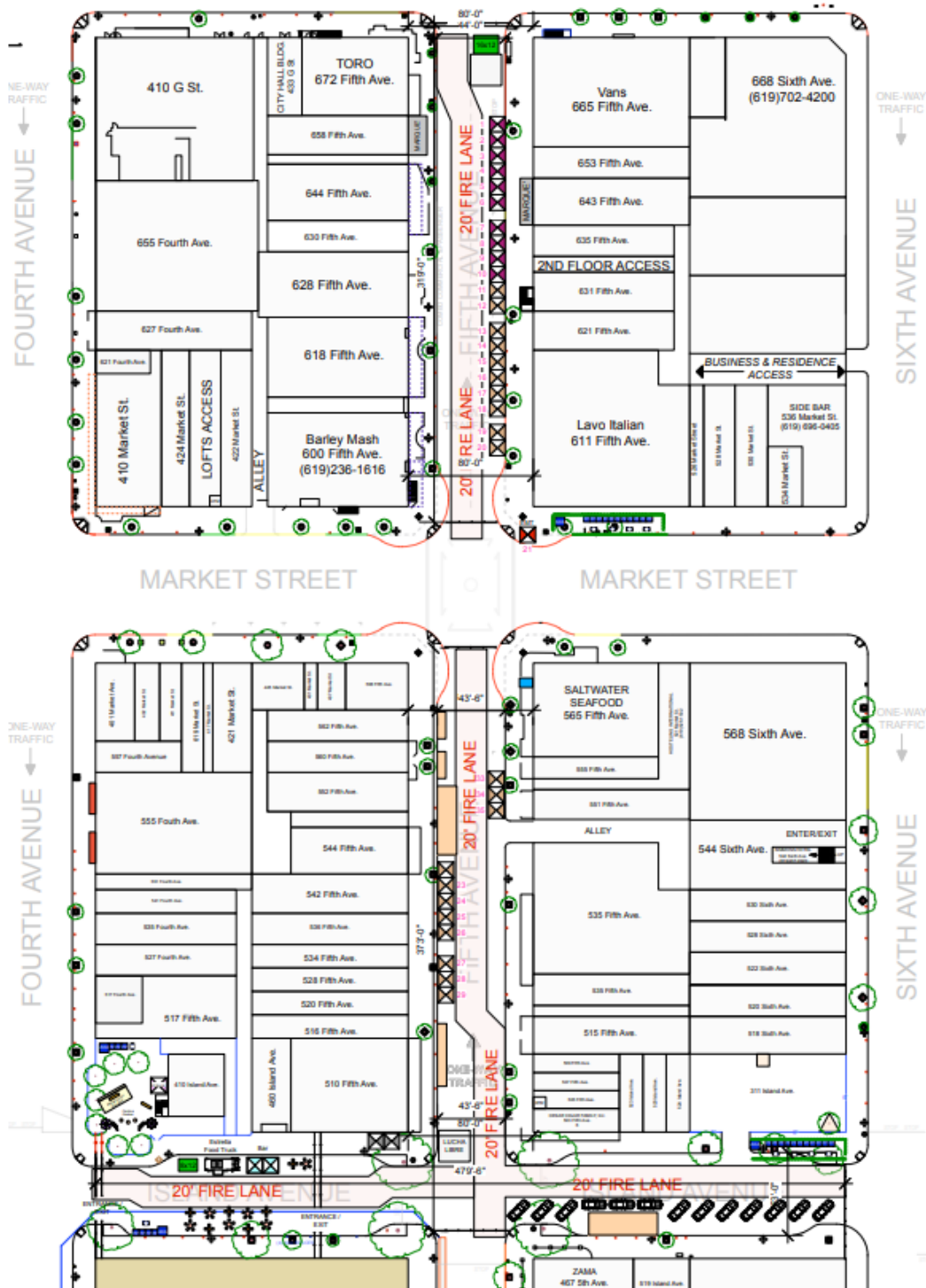

Send the completed appeal application form (including grounds for appeal and supporting documentation in pdf format) by email to Hearings1@sandiego.gov by 5:00p.m. on the last day of the appeal period; your email appeal will be acknowledged within 24 business hours. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
