NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit - North Park Salsa Fest
COMMUNITY PLAN AREA: North Park
COUNCIL DISTRICT: 3
LOCATION: North Park Mini Park, 3812 29th Street, Granada Ave.

PROJECT DESCRIPTION: Special Event Permit for a salsa tasting at the North Park Mini Park located at 3812 29th Street, on Granada Ave. and North Park Way, on May 3, 2025. The event would include alcohol, live performances, activities for kids, tents, inflatable bounce house, sound amplification, fencing and/or barricades, onsite food preparation, food sampling, food trucks, beverages, tables, chairs, portable restrooms, and recycling and trash containers. Sound amplification from performances would occur from 11:30 AM until 5 PM. Noise associated with the event activities and set-up/dismantling would occur from 7 AM to 7 PM on May 3, 2025. Set-up would occur from 7 AM to 11:30 AM, the event would occur from 11:30 AM to 5 PM and clean-up/dismantling would occur from 5 PM to 7 PM.

There would be road and parking closures associated with the event and would occur on May 3, 2025, from 7 AM until 6 PM, and would include Granada Avenue from North Park Way to University Avenue, North Park Way between Granada Avenue and 29th Street.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
