## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## SPECIAL EVENTS DEPARTMENT

**PROJECT NAME:** Special Event Permit - HoodBeast Block Party **COMMUNITY PLAN AREA:** Southeastern San Diego **COUNCIL DISTRICT:** 9 **LOCATION:** Market St. between Derby, Toyne and 42nd St.

**PROJECT DESCRIPTION:** Special Event Permit for a community social gathering that would include food vendors, food trucks, onsite food preparation, the temporary use of a stage, fencing and/or barriers, portable restrooms, canopies, tables, chairs, bleachers, trash/recycling containers, and generators that would occur on 4200 Market St between Derby, Toyne and 42nd Street on May 10, 2025. Approximately 300 attendees are anticipated throughout the course of the event. Noise associated with the event activities and set-up/dismantling would occur from 7 AM until 11:55 PM on May 10, 2025. There would be entertainment, and sound amplification would occur from 11 AM until 10 PM on May 10, 2025. Set-up for the event would occur from 7 AM until 11:55 PM.

Road and parking closures would be associated with this event and would occur from 7 AM until 11:45 PM on May 10, 2025, and would include 4200 Market Street from Derby to 42<sup>nd</sup> Street, Toyne Street.

## ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
