# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - Tierrasanta Kiwanis Patriots Day Parade

**COMMUNITY PLAN AREA:** Tierrasanta

**COUNCIL DISTRICT:** 7

**LOCATION:** 5156 Santo Rd., Tierrasanta Boulevard, Santo Road, La Cuenta Drive, Baroque Lane

**PROJECT DESCRIPTION:** Special Event Permit for a Tierrasanta Parade that would occur on May 17, 2025. The parade would include vehicle, floats, motorized, marching units, entertainment, sound amplification, and trash/recycling containers. Noise associated with the event activities and set-up/dismantling would occur from 7:30 AM until 11:50 AM on May 17, 2025. Sound amplification would occur from the parade announcers and music would occur from 9:15 AM until 11:45 AM. On May 17, 2025, set-up for the parade would occur between 7:30 AM and 9:45 AM, the parade would occur from 10 AM until 11:45 AM, and the parade would be dismantled between 11:45 AM and 11:50 AM. The parade would start at Canyon Hill High School, 5156 Santo Road, heading south on Santo Rd., left on Tierrasanta Blvd. to La Cuenta, right on La Cuenta to Baroque Lane, left on Baroque Lane and ends at the Legacy Church parking lot. The assemble area would take place in the Canyon Hills Parking Lot. See route map attached.

Road closures would occur from 9 AM until 12 PM on May 17, 2025, and would include

- Southbound Santos Road between Clairemont Mesa Boulevard and Tierrasanta Blvd.
- Tierrasanta Boulevard between Santo Road and La Cuenta Drive,
- La Cuenta Drive between Tierrasanta Boulevard and Baroque Lane
- Baroque Lane between La Cuenta Drive and Ducos
- Ducos between Baroque Lane and Tierrasanta Boulevard

Parking closures would occur from 7 AM until 12 PM on May 17, 2025, for above streets listed above.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
