NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – Law Enforcement Torch Run for Special Olympics **COMMUNITY PLAN AREA:** Barrio Logan, Downtown, Midway, Mission Bay Park, Pacific Beach, La Jolla, University City, and Torrey Pines

COUNCIL DISTRICT: 1, 2, 3, 8

LOCATION: Roadways through Barrio Logan, Downtown, Midway, Mission Bay Park, Pacific Beach, La Jolla, University City, and Torrey Pines (see attached maps and route descriptions)

PROJECT DESCRIPTION: Special Event Permit for that portion of the Law Enforcement Torch Run for Special Olympics Southern California event that would occur within the City of San Diego right-of-way jurisdiction on May 27, 2025. Noise associated with the event activities and set-up/dismantling would occur from 9:30 AM until 4 PM on May 27, 2025. Set up would occur from 9:30 AM to 10 AM, the event would occur from 10:15 AM to 4 PM, and dismantling would occur from 4 PM until 4 PM. The route within the City of San Diego's jurisdiction is shown on the attached maps and route descriptions.

No road closures would occur with this event within the City of San Diego's jurisdiction. Intersection monitoring and delays may occur as runners make their way along the route. The route and run would obey rules of the road.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
