Annual Report 2024-2025

Chollas Valley Community Planning Group (CVCPG)

Activities and Accomplishments

Reporting Period: May 15, 2024 – April 15, 2025



Executive Summary

This report summarizes the major actions, leadership, and advocacy of the Chollas Valley Community Planning Group (CVCPG) during the reporting period. It highlights CVCPG's main focus and central role in supporting lawful planning practices that facilitated affirmatively furthering fair housing (AFFH), leading citywide advocacy for the principles embedded within that law, and elevating community participation and visibility in public policy processes.



1. Community Advocacy, Outreach and Impact

- ➤ Filed CVCPG's first-ever appeal: challenged an environmental determination that the Klauber Project was consistent with the community plan or zoning. As a result, the environmental determination was rejected by the city council at the November 12 hearing for the appeal.
- > The CVCPG chair spoke on behalf of the individual appellant who attended the CVCPG special meeting of June 24, 2024, to discuss and vote on a motion to appeal. The individual's appeal was identical ---word-forword--- to that submitted by CVCPG. The individual appellant, who attended the CVCPG special meeting where the appeal was discussed and voted on, may have legally been a co-appellant alongside CVCPG in the environmental appeal.
- Successfully advocated through letters and oral comment during city council meetings, alongside the district 4 Councilmember, Henry Foster III, to not actualize a Safe Parking location at Valencia Park/Malcolm X Library as proposed by the Homelessness Strategies and Solutions Department. CVCPG unflinchingly argued that the placement would be counter to the principle of de-

- concentrating poverty----a principle embedded within Affirmatively Furthering Fair Housing (AFFH) law.
- ➤ Through consistent oral comment and letter-writing, CVCPG contributed significantly to the routine use of the term, "Affirmatively Furthering Fair Housing (AFFH)" within the City of San Diego's official written and oral discourse.

- ➤ Held what were likely the two most well-attended CVCPG meetings ever: Over 130 attendees on October 28, 2024, to discuss the impact of Footnote 7 on the Klauber and Old Memory Lane projects. Over 100 attendees on November 18. 2024 at a meeting attended by the Planning Department director, Heidi Vonblum, to discuss the city's proposed timeline to repeal Footnote 7.
- ➤ The KPBS story chronicling CVCPG's leadership in discovering and organizing opposition to Footnote 7 was the station's most-viewed video-story of 2024 and was featured on KPBS Roundtable. See Appendix C.
- ➤ Through its Community Planners Committee (CPC) representation, coauthored a letter addressing the fire hazards of the city's ADU Density Bonus Program
- ➤ Championed increased community participation at city council meetings, leading to overflow and standing-room-only attendance.



- ★ Established and fostered a collaborative partnership relationship with an elementary school. In the Chollas Valey plan area, KIPP Adelante Preparatory Academy, showcasing resources and providing cross-promotion opportunities.
- ★ In partnership with Groundwork San Diego, employed one Chollas Valley youth as a paid intern for administrative support and one Chollas Valley adult resident for audio, facility, and logistics support in partnership with Groundwork San Diego through a grant secured by Groundwork San Diego and personal donations from CVCPG members to Groundwork San Diego for this purpose.
- → In partnership with *Groundwork San Diego*, new audio and teleconferencing equipment was purchased, significantly enhancing and increasing remote meeting participation. Previously, remote participants had great difficulty hearing in-person participants that were not nearest to the computer operating the Zoom connection.
- ♣ Greatly improved the CVCPG website so that documents are publicly accessible such as correspondence with city officials on major issues, CVCPG agendas, CVCPG meeting minutes, news coverage of CVCPG-led advocacy, and notices of hearings and agenda items on CVCPG issues during city council and planning commission meetings.
- → Eleven residents submitted applications for CVCPG membership who have never served. This was very likely a record.
- ◆ Completed approval of minutes of regular and special meetings from January 2024 through April 2024 from previous board administration.
- ◆ 13 of 14 CVCPG members completed the live real-time mandatory
 Community Orientation Workshop (COW) for 2024-2025 conducted by the
 City of San Diego Planning Department. The single remaining member
 completed the make-up training on the first date that CPGs were notified of

the members who had not completed the training

- ◆ Achieved a quorum at every noticed meeting—regular or special—without the need for RSVP reminders.
- ◆ Member Michael Westmoreland upgraded the meeting nameplates to better reflect the gravity of CVCPG's responsibilities.

The previous 5 bullet items are noteworthy given the barriers to civic engagement in areas of low resources such as Chollas Valley. Unlike most other community planning groups in the city, the majority of CVCPG members are employed full-time.

2. Challenge to Footnote 7 Based on AFFH & Other City, State and Federal Law



- ❖ CVCPG submitted letters to elected city official and their staff as well as oral comment before the planning commission and the city council opposing Footnote 7 of Table 131-04D of the San Diego Municipal Code. Footnote 7 uniquely impacted historically underserved communities in the Chollas Valley community plan area. CVCPG formally presented the issue before the Community Planners Committee (CPC) and helped craft the CPC letter that urged that was instrumental in unanimous repeal of Footnote 7 by the city council. - ❖ Facilitated the adoption of yellow t-shirts as a recognizable symbol of grassroots advocacy by residents from San Diego communities.. This began with Chollas Valley residents mobilizing at city hall in opposition to Footnote 7.

3. Repeal or Reform of the ADU Bonus Density Program

CVCPG submitted an attorney-drafted letter calling for the repeal of the ADU Bonus Density Program, citing disparate impact, violations of fair housing laws and the Americans with Disability Act (ADA), displacement risk, and inconsistencies with the city's general plan, particularly its equity and environmental justice elements. The letter argued that the policy applied density in an inequitable manner without providing affordability guarantees or adequate infrastructure.

➡ With technical assistance from Neighbors for a Better San Diego and We are Encanto, CVCPG submitted a letter to city officials, elected and staff, as well as to the governor of California that called for a halt to all projects that do not comply with the San Diego Municipal code requirements of the ADU Bonus Program that permitted projects have a complete, ADA compliant pedestrian pathway from the project to a transit stop.

4. Legislative Outreach and Citywide Coalition Leadership



Throughout the reporting period, CVCPG strengthened its civic influence by engaging with the offices of Senator Dr. Akilah Weber Pierson and Assemblymember LaShae Sharp Collins to address persistent planning inequities between communities south and north of Interstate 8, and by building partnerships with community groups across San Diego, most notably Neighbors for a Better San Diego. The League of Women Voters—a nationally recognized and highly respected nonpartisan organization with a long history of promoting informed

civic participation—submitted a letter to the city council urging the repeal of Footnote 7; an effort initiated and spearheaded by CVCPG.

CVCPG was a citywide leader in speech and action that promoted equity-based planning and AFFH compliance through letters to city officials and testimony before the city council as well as the chair's and vice chair's advocacy underscoring CVCPG positions during Community Planners Committee (CPC) meetings.
