Street Reconstruction Group 1801

• The website was last updated on February 27th

• For Parkdale, the contractor initially hoped that the concrete samples (tested at 7 and 14 days) would meet the necessary strength early, allowing them to start paving sooner. However, those early tests didn't meet the needed criteria. Now, they have to wait for the 28-day test results, which are showing positive trends and look like they will meet the required standards. Therefore, paving had been moved to mid-March. Given the recent rain, this may impact the previously stated timeline.

- Water relocation work along Gold Coast Court and Gold Coast Way has begun and is currently ongoing.
- Estimated Completion: Early 2026

Section I. Introduction.

This is the annual report for the Mira Mesa Community Planning Group (MMCPG). For the period covered, the MMCPG officers were Chris Cate, Chair; Sean Tompkins, Vice-Chair, Tiffany English, Secretary.

Section II. Administrative Matters.

The MMCPG has 19 members: 11 residential, 5 business and 3 property owner members.

Nine regular meetings were held during the reporting period. Meetings were held on the third Monday of each month at 7 PM, with few exceptions due to holidays.

Section III. Resignations

At the time of adoption of the Annual Report, the MMCPG has XXX vacancies, X business seat(s) and X property owner(s) seats. The MMCPG previously had one resident seat resignation during 2023, and a replacement was appointed in accordance with the Bylaws.

Section IV. Members Summary

Elections are held every two years and the last biennial election was held in March 2025. Three members had reached their 8-year term limit.
