#### DEFINED CONTRIBUTION PLANS TRUSTEE MEETING MINUTES

### Wednesday, February 19, 2025

The Defined Contribution Plans Trustee Board of the City of San Diego held a special meeting on Wednesday, February 19, 2025. The meeting was a hybrid meeting conducted in person at the Civic Center Plaza, 1200 Third Ave., 15th Floor Conference Room, San Diego, CA, 92101 and virtually via Microsoft Teams. Action Items 1B and 1C were presented together. The current record-keeper contract with Principal is ending on December 31, 2025, resulting in the need to perform a third-party administrator search for a new record-keeper, with a contract effective January 1. Staff recommended approval to enter into an agreement with Segal Marco to perform the record-keeper search for a fee of \$100,000. Staff also recommended approval of an amendment of the current Segal Marco investment consulting contract for an extension of one additional year to allow Segal Marco to continue as the investment consultant while they perform the record-keeper search, and to provide consistency across the transition to a new provider, should a new record-keeper ultimately be chosen. The total fee for the additional one-year period is \$72,500, which represents a three percent (3%) increase over the level of the current contract.
