# **Solution** Morena Conveyance South & Middle Alignment



### Night Work: Clairemont Dr & Clairemont Mesa Blvd.

#### 48" and 30" Pipeline Schedule:


- Last night of night work is Thursday, 4/17
- Sunday nights through Friday mornings
- Nighttime installation (9 p.m. 6 a.m.)
- Noise & dust during working hours

#### Traffic Control:

- Intersection closed during working hours
  - Detours for all travel directions
- Intersection will be fully open with steel plates during day non -working hours
- All businesses remain open in the area
- Emergency responders access maintained at all times

#### Next Milestone:

 Opening Clairemont Dr. and Clairemont Mesa Blvd. intersection all hours

# **SD** Day Work: Clairemont Mesa Blvd. to Lakehurst Ave.

#### 48" and 30" Pipeline Schedule:

- Monday through Friday
- Daytime installation (7:00am 4:30pm)
- Nighttime welding (4:30pm 11:00pm)
- Noise & dust during working hours

#### Traffic Control:

- Will be installed overnight 4/17
- One lane of traffic in each direction
- Approximately 4 weeks of work
- Access to North Clairemont Library maintained
- Emergency responders access maintained at all times

 Clairemont Drive and Clairemont Mesa Boulevard Intersection

#### 48" and 30" Pipeline Schedule:


- Monday through Friday

#### Current 24 -hr Traffic Control:


- Milton St. & Chicago St. moving north on Chicago St.
- Approximately 6 weeks of work per block, 24/7 street closure
- Alley and sidewalk access maintained at all times.
- Emergency responders access maintained at all times.

#### 48" and 30" Pipeline Schedule:


- Monday through Friday
- Daytime installation (4:30am 1:30pm)
- Nighttime welding (1:30pm 11:00pm)

#### Current 24 -hr Traffic Control:

- 24-hour northbound closure on W. Morena Blvd between Vega Street and Morena Blvd
- All businesses remain open in the area
- Emergency responders access maintained at all times

#### Next Milestone:

 Crews will continue northbound on West Morena Blvd, then turn east onto Milton Street

# SD Paving and Bike Lane Overview

#### Final Paving and Bike Lanes:

- 6.9 miles will receive final paving in 8 -phases
  - After pipeline and street improvements are completed
- Phase 1 Clairemont Dr from Erie St to Iroquois Ave
  - Completed February 2025
- Phase 2- Clairemont Dr from Iroquois Ave to Balboa
  - Expected in June 2025
- New Bike Lanes will be implemented after paving
  - City Mobility Design Team started coordination with Community back in 2019







# SD Paving and Bike Lane Overview

#### Work to be completed before paving:


- 48" and 30" Pipeline installation
- Installation of pipeline appurtenances
- Both Pipelines must Pass Testing
- 167 ADA Curb Ramps upgrades
  - May also contain electrical upgrades
- Additional Concrete Work
  - Medians, sidewalk panels, cross gutters

### Final Paving and Bike Lanes:

- 6.9 miles alignment will be paved in 8 phases
- Phase 1- Clairemont Drive from Erie St to Iroquois Ave
  - Started February 2025
- New Bike Lanes will be implemented after final paving
- Coordinated with Community since 2019
  - September 2019 Subcommittee
  - January 2020 Subcommitee
  - District 2 Budget Request Memo for Separated Bikeways FY22
