NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Cisco Kick Off Event **COMMUNITY PLAN AREA:** Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** J Street between Seventh and Tenth Avenue

PROJECT DESCRIPTION: Special Event Permit for a private event that would include, food trucks, onsite food preparation, alcohol, fencing and/or barriers, canopies, temporary structures, tables, chairs, a stage, trash/recycling containers, and portable restrooms that would occur at in Gallagher Square at Petco Park and involve an extension of the existing J Street closure in Downtown on June 11, 2025. Noise associated with the event activities and set-up/dismantling would occur from 10 PM on June 10, 2025, until 8 AM on June 12, 2025. Set-up would occur from 10 PM on June 11, 2025. On June 11, 2025, the event would occur from 6:30 PM until 11 PM. Dismantling would occur from 11 PM on June 11, 2025, until 8 AM on June 11, 2025. Sound amplification would occur from 6 PM until 10 PM on June 11, 2025.

Road, street parking, and bike closures would be associated with this event and would occur from 10 PM on June 10, 2025, until 6 AM on June 12, 2025, on J Street between Seventh and Tenth Avenue. See map attached.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
