NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Taste of Little Italy Tasting Garden
COMMUNITY PLAN AREA: Downtown
COUNCIL DISTRICT: 3
LOCATION: Date Street between India Street and Kettner Blvd.

PROJECT DESCRIPTION: Special Event Permit for a community food and wine event that would include the temporary use of sound amplification, tents, fencing and/or barriers, beer garden, alcohol, tables, chairs, trash, and recycling containers that would occur on Date Street between India Street and Kettner Blvd. on June 17 & 18, 2025. Alcohol would be served from 4 PM until 7:30 PM on June 17 & 18, 2025. Noise associated with the event activities and set-up/dismantling would occur from 2 PM on June 17, 2025, until 9 PM on June 18, 2025. Set-up for the event would occur from 2 PM until 4 PM on June 17, 2025, and from 3:45 PM until 4 PM on June 18, 2025. The 2-day event would occur from 4 PM until 8 PM on June 17, 2025, and June 18, 2025. Dismantling would occur from 8 PM until 9 PM on June 17, 2025, and June 18, 2025.

There would be road and parking closures associated with this event and would include W. Date Street between India Street and Kettner Blvd. from 2 PM until 9 PM on June 17, 2025, and from 3:45 PM until 9 PM on June 18, 2025.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing

commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
