MTS is undertaking a Transit Center expansion project at their 12th & Imperial Transit Center. The MTS project will expand and reorganize the existing bus transit center at the 12th & Imperial station. MTS filed our application for Street Vacation (PRJ – 1132335) with the City and it is currently in the Project Review phase.
