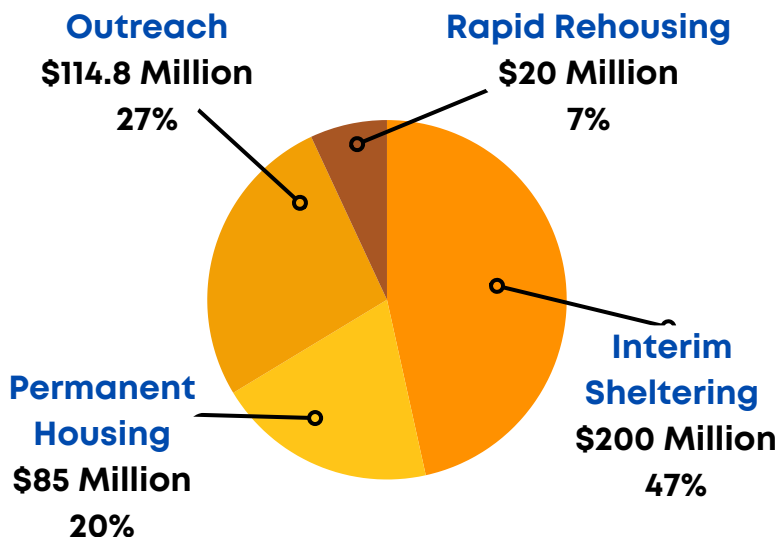


ACCOUNTABILITY UPDATE

HHAP ROUNDS 1-4

The Big City Mayors (BCM) are committed to reducing homelessness across the state. HHAP rounds 1-4 have provided critical funding for our cities to tackle this crisis head on. To sustain this momentum, it's critical that the state extend funding for HHAP Rounds 6 and 7, ensuring cities can continue delivering housing, services, and support to those most in need.

Extend HHAP and Finish the Work

- In 2024, California experienced an **increase of 3%** in homelessness, significantly less than the nationwide increase of 18%.
- Additionally, the state saw a **decrease in chronically homeless** individuals. Let's keep the momentum going.
- With **federal housing funds proposed to be cut by 44%**, California's largest cities urgently need committed state support.
- With support, cities have shifted from crisis response to long-term solutions—**but without continued funding, that progress is at risk.**
- California's big cities have shovel-ready projects, an additional **4,646 housing units are in the pipeline** due to anticipated HHAP funds, but without committed funding, **progress will come to a halt.**

HHAP FUNDS IN ACTION

Big City Mayors have risen to California's homelessness challenge. HHAP dollars are unique in that they provide cities the flexibility to respond to the unique homeless needs of their community. Without ongoing funding, future programming, services and housing are at risk.

Anaheim

8,000+ people have been aided by HHAP-funded programs

Better Way Anaheim provides pathways to work for the unhoused to give them lasting stability. A previously unhoused single mother now has employment inputting HHAP data into HMIS through this program.

Bakersfield

- **52,000** shelter bed nights
- Housing stability for **100+** youth
- **900** individuals have been served

Fresno

3,000+ housing units in development

Mobile Shower Program

- **13,000+** showers provided to date
- Operational 5 days a week
- Hygiene kits & clean clothing provided

Long Beach

Developing a **Youth Shelter & Navigation Center**

- An important milestone in its commitment to end youth homelessness
- The center will offer on-site beds & comprehensive supportive services

San Diego

Safe Parking Program

- 24-hour lot for **86 vehicles**
- Two overnight-only lots for **60 vehicles**
- Family-focused site with **19 state-provided camper trailers**
- Served **3,230 people**, including 550+ children

16,000+ people have accessed HHAP-funded support services.

San Francisco

- **2,400+** encampment operations
 - **8,434** people placed into shelter

- **1,850** shelter beds added
 - **13%** drop in street homelessness since 2022

Riverside

In March 2025, Riverside reached **functional zero for youth homelessness**, with available resources now surpassing the needs of residents aged 18 to 24.

Motel Conversion Project

- **94 permanent supportive housing units** in the pipeline
- A percentage reserved for veterans and individuals with disabilities
