ITEM 1: 3333 KELLOGG WAY – PROJECT NO. 1121168

Plan Area: Peninsula

Coastal Development Permit for slope repair and construction of a retaining wall due to slope failure at a site with an existing single-dwelling unit. The 0.28-acre site is located at 3333 Kellogg Way in the RS-1-4 (Residential-Single Unit) zone, the Coastal Height Limit Overlay Zone, the Coastal Overlay Zone (Appealable), the Coastal Overlay Zone First Public Roadway, a Transit Priority Area, the ALUCP Airport Influence Area (San Diego International Airport - Review Area 2 and NAS North Island - Review Area 2), and the FAA Part 77 Noticing Area (Naval Air Station North Island and San Diego International Airport) within the Peninsula Community Plan.

This project was determined to be categorically exempt pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act. [Report No. HO-25-021](#).

ITEM 2: 5970 CAMINO DE LA COSTA – PROJECT NO. 1091933

Plan Area: La Jolla Community Plan Area

Coastal Development Permit and Site Development Permit to demolish an existing single-dwelling unit and construct a new 2,391-square-foot detached guest quarters, a 760-square-foot Accessory Dwelling Unit, a 5,206-square-foot subterranean garage with habitable space, and a 1,255-square-foot covered terrace. The project is located at 5970 and 5990 Camino De La Costa in the RS-1-5 (Residential-Single Unit) zone, the Coastal Height Limit Overlay Zone, the Coastal Overlay Zone (Appealable), the Coastal Overlay Zone First Public Roadway, the Parking Impact Overlay Zone, the Sensitive Coastal Overlay Zone, and a Transit Priority Area within the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act. [Report No. HO-25-014](#).

ITEM 3: 627 GENTER STREET – PROJECT NO. 1055455

City Council District: 1

Plan Area: La Jolla

Coastal Development Permit and Conditional Use Permit for proposed additions and renovations to an existing education building on an existing religious assembly campus. Site additions include 2,270 square feet of new construction, consisting of a 592-square-foot addition to the first floor, a 592-square-foot addition to the second floor, and a 584-square-foot addition to create a new third floor, plus 502 square feet of new roof decking. Renovations include 2,340 square feet of interior improvements and replacement of exterior access stairs. The 0.48-acre project site is located at 627 Genter Street in the RM-1-1 (Residential-Multiple Unit) zone, the Coastal Height Limit Overlay Zone, the Coastal Overlay Zone (Non-Appealable), the Transit Area Overlay Zone, and a Transit Priority Area within the La Jolla Community Plan.

This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 (Existing Facilities) on September 5, 2024. An appeal of the CEQA determination was previously made, and the City Council denied the CEQA appeal on March 18, 2025. The scope of the subject hearing only includes the project, and not the environmental determination. [Report No. HO-25-022](#).

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*
