- True North Research Conducting customer satisfaction surveys on behalf of the Golf Division
- since 2011
- Independent Research Firm

Methodology

- Over 1,100 randomly selected customers completed the survey by telephone or email
- Customers who played City Courses in Fiscal Year 2024
- Customers were recruited by email invitations and telephone
- The maximum margin of error for this study is +2.9%



Torrey Pines South Course

- Enforce speed of play (11%)
- Reduce fees, costs in general (8.1%)
- Improve access to tee time info (7.5%)
- Increase availability of tee times (7.2%)

- Increase availability of tee times (8.5%)
- Reduce fees, costs in general (7.7%)
- Improve access to tee time info (7.2%)

Balboa Park Golf Course

- Enforce speed of play (10.7%)
- Maintain tee boxes (6.5%)
- Improve fairways (5.2%)
- Improve greens conditions (5.0%)

Mission Bay Golf Course

- Maintain tee boxes (9.4%)
- Better lighting, extended hours (7.2%)
- Improve course quality (5.9%)
- Improve green conditions (5.6%)
