Item 2: Approval of the Meeting Minutes (Action)

Chair Olascoaga asked the Mobility Board to review and approve the minutes from its March 19, 2025 and April 2, 2025 meetings.

There were no public comments on this item.

<u>Action</u>: The March 19, 2025, meeting minutes were approved upon a motion by Daniel Reeves and a second by Harry Bubbins. Anar Salayev abstained from the vote and all other members in attendance voted 'Yes'.

<u>Action</u>: Steve Gelb (virtual) noted that Item 6 needed to be corrected to include Wayne Landon as a member of the Vison Zero subcommittee. With that correction, the April 2, 2025 meeting minutes were approved upon a motion by Anar Salayev and a second by Jeff Dosick, with all members in attendance voting 'Yes'.

Item 3: Non-Agenda Public Comment

There were no public comments on this item.

Anar Salayev noted that on Monday, May 12 at 9am, Councilmember Whitburn's office, Uptown Community Planning Group, North Park Planning Committee, Bike SD, and Families for Safe Streets will host a press conference on the Fix the Fork Campaign regarding the El Cajon Blvd., Normal St, Park Blvd. intersection.

Item 4: Draft Budget for Fiscal Year 2026 (Information)

Philip Trom, Mobility Board liaison, provided an overview of the April 15, 2025 draft budget for FY 2026 (July 1, 2025 - June 30, 2026). The draft budget includes a number of proposed reductions to City services and City positions to address the anticipated reduction in budget revenue for the Fiscal Year.

There were no public comments on this item.

Daniel Reeves asked if there had been a detailed breakdown on the parking meter revenue that will be received by the City and the Community Parking Districts. Phil Trom, Mobility Board liaison, will follow-up on this request.

Harry Bubbins noted that there was a lot of skepticism at the City Council regarding a \$600,000 study for the Fix the Fork campaign and the Mobility Board may be able to advise on how to efficiently implement safety features.

Mobility Board members discussed how the Board should be involved in providing feedback during the budget process. The Board decided to review the memo outlining Board priorities from last September, compare it to the Council priority memos, and reinforce the Mobility Board's support for the items that are proposed for inclusion in the FY 2026 budget.

Item 5: Mobility Board Membership and Work Plan (Discussion/Possible Action)

Chair Rosa Olascoaga introduced the item and Phil Trom, Mobility Board liaison, provided an overview of the workplan structure including goals, objectives, and deliverables.

There were no public comments on this item.

Mobility Board members discussed why items were added to the workplan and reviewed potential changes to the document. It was noted that the Vision Zero Subcommittee will meet this month to discuss the Vision Zero item. The Board also discussed folding the Community Plan alignment item into future input on those Plans once they are heard by the Mobility Board.




Getting Kids to School Safely Requests





These are the 6 most dangerous pedestrian streets in San Diego as identified by SANDAG's Regional Safety Focus Network – all along school routes. (\$1.725M)









We know that speeding is a leading cause of crashes. AB43, allows local agencies to set school zone speed limits of 15 mph within 500 ft of a school and speed limits of 25 mph when 500-1,000 feet from a school.(\$150K)





D8 & 3: Planned Construction & Proximity to Schools

Broadway and Market Street corridors are each within 0.25 miles of 6 and 5 schools, respectively.



District 8 & 3: Broadway: N. Harbor to 21st



\$345,000

Includes:

- Speed hump at 17th to reduce speeds coming into downtown, including warning paint. Combined with crosswalk would make this a raised crosswalk.
- Restriping crosswalks at 1st, 4th, 8th, 9th, 10th, and 11th streets.
- Remove crossing prohibitions and introduce crosswalks at 17th and 20th streets to reduce space between crossing points.
- Painted crosswalks and Rapid Rectangular Flashing Beacons at 20th and 15th streets.



Includes:

- Centerline hardening at 15th, 17th, and 21st street medians to reduce speeds.
- Curb extensions at 22nd street.

- Restriping of crosswalks at 24th, 13th, 11th, and 7th streets.
- Speed hump at 17th to reduce speeds going into downtown, including warning paint.
- School Zone pavement paint at 20th and 25th street intersections.














49th x El Cajon: Dangerous place to cross. Need to improve adjacent intersections or completely redesign this one. Major bus stops 1 block east. Improvements include: centerline hardening, refuge island, painted crosswalk.






Example of potential improvement: El Cajon and the 15 freeway







50th x El Cajon, Altadena x El Cajon: Pedestrian Hybrid Beacons are a good starting point, but not there yet. These intersections need either curb extensions or slow turn wedges, also improved lighting.

Estimated Cost: Low: \$44,000 High: \$70,000






Winona x El Cajon: Pedestrian signal takes a whole cycle after pressing, even if you press right after the light turns green. Pedestrians go anyway. Leading Pedestrian Intervals on the intersections from 48th to Altadena would also help.

Estimate Cost: \$3,000

The whole stretch: Lighting is generally poor on this stretch of road. Many of the old street lights need to be upgraded to increase visibility.

Subject: Requests for Fiscal Year 2026 Budget

Dear Mayor Gloria and Councilmembers,

We are writing on behalf of the City of San Diego Mobility Board to propose recommendations for the FY 2026 budget cycle of the City of San Diego. We appreciate the leadership that you have shown in developing safe and sustainable mobility options. We emphasize the importance of prioritizing mobility investments for historically underserved communities of concern. We urge the City of San Diego to allocate funds for safety improvements aimed at addressing the Fatal 15 intersections during this budget cycle. We look forward to continuing to work together to build a truly multi-modal system in San Diego.

In alignment with our overarching objectives of equity, safety, and climate action, we are proposing a list of citywide mobility priorities for inclusion in the Fiscal Year 2026 budget cycle:

Citywide General Priorities

Addressing the Deficiency of Pedestrian Infrastructure:

Prioritize the enhancement of pedestrian infrastructure and safety in the Fiscal Year 2026 budget. This includes updating and fully implementing the <u>Pedestrian Master Plan</u> (2006), with a focus on areas lacking sidewalks. Well-maintained <u>sidewalks</u> are essential to Vision Zero goals, and the City should increase funding for sidewalk repairs and new installations. We propose the development of a policy framework for pedestrian boulevards and <u>pedestrian-only corridors</u>, emphasizing <u>lighting</u>, <u>shade</u>, <u>and seating</u> to ensure safety and comfort for pedestrians and public transit users. Additionally, funding should be allocated for new streetlights, replace old stop signs, and tree planting, supporting the 2022 Climate Action Plan goal of planting 40,000 new trees by 2030 in Communities of Concern. Investments in fixing the <u>most dangerous</u> intersections, as identified in the Systemic Safety Analysis Report Program, should focus on cost-effective safety measures like lead pedestrian intervals, countdown timers, high-visibility crosswalks, curb extensions, and roundabouts. Lastly, the City should establish a <u>Healthy</u> <u>Commuter Incentive Program</u> to promote sustainable and active commuting for City employees.

Addressing Missing Links in the Bike Network:

Prioritize off-cycle resurfacing to <u>complete essential bike network connections</u> on dangerous roads and allocate funding for full-build bikeways during resurfacing. This will improve the bikeway network efficiently in key areas of San Diego. <u>Strengthen parking and code</u> <u>enforcement in bikeways</u>, particularly in the urban core, by assigning two parking enforcement officers to curb illegal parking and parklet encroachments. Utilize the NACTO Urban Bikeway Design Guide as the standard for new bike facilities, aligning with the city's goals and the latest safety classifications. Restore funding for <u>Vision Zero education programs</u> and support active transportation campaigns. Continue funding the <u>Safe and Sustainable Transportation for All</u> <u>Ages and Abilities Team</u> (STAAT) to expedite quick-build and protected bikeways, supporting Climate Action Plan and Vision Zero goals.

Transit and Micro Mobility Improvements

<u>Transit-only lanes</u> have the potential to transform bus routes into the most efficient transportation options. The City should study and implement transit lanes on its most congested corridors. Prioritize funding for <u>immediate and/or low-cost transit solutions</u> benefiting low-income communities including flexible fleet programs, youth opportunity passes, and expanded bus routes and service frequency. Enhance connectivity to major transit stations and bridge transit deserts by investing in ways to connect people to the transit network. This includes enhancing pedestrian and bicycle infrastructure, standing up first and last-mile micro-transit solutions, and partnering with private-sector, transit-oriented developments to share in the cost and benefit of these solutions. <u>Collaborate with SANDAG</u>, <u>MTS</u>, <u>NCTD</u>, and local jurisdictions to improve connectivity by urging adoption and investment in transit-complimentary solutions such as bike-share, scooter programs, and EV shuttles, and accelerate the development of multi-modal mobility hubs that encourage mode shift.

District Specific Priorities

In addition to the broad priorities outlined above, the mobility board has identified several Capital Improvement Projects that we believe should be prioritized for funding in the coming fiscal year. For projects that are in the bid/award phase, inclusion in this list means that the Mobility Board believes that such projects should be prioritized for construction as soon as possible. For projects that are in a more preliminary phase, inclusion means that the Mobility Board believes such projects are ripe for the addition of enhancements that should be considered now when such modifications are most cost-effective and before they require significant, costly redesign. The projects to be prioritized are listed by Council District below:

Capital Improvement Program List Priorities:

District 1:

- Completion of the Coastal Rail Trail on Gilman Drive.
- Install additional traffic calming solutions at Beryl St and Lamont St intersection.
- Facilitate pedestrian and bicycle access on Garnet Ave, west of Ingraham Drive.

• Fund the completion of PB Pathways Phase 3.

District 2:

- Fund CPI Project B19212: Completion of Robb Field Gateway Path.
- Install Voltaire St. at Poinsettia Dr. roundabout.
- Install Class IV bikeway W. Point Loma Blvd. from Nimitz Blvd. to Adrian St originally a part of CPI Project B22115.
- Enhance the bicycle and pedestrian connection between Pacific Beach and the Balboa Ave. Trolley station.

District 3:

- Fund El Cajon & Kansas Traffic Signal (B20140 Transportation Asset).
- Completion of 6th Ave @ Juniper St Roundabout (B20142 Transportation Asset).
- Fund Washington & Albatross HAWK (B24118 Transportation Asset).
- Fund Golf Course Drive Improvements (S15040 Parks Asset). This project would benefit from enhancement during the design phase to ensure sufficiently safe bicycle infrastructure is included.
- Create clear connections between the downtown Mobility Network and the Embarcadero, especially on J St. cycle track via the bike path along the railroad tracks.

District 4:

- Funding for Gompers Prep 47th St Safety Enhancements (B23146-Transportation Asset).
- Repaving and Resurfacing for Logan Avenue/ Encina Dr, from Euclid Avenue to Santa Isabella Dr.
- Prioritize funding for constructing sidewalks in District 4 where there is none of them example- Groveland Drive in Valencia Park.
- Install a safe, signalized pedestrian crossing on Euclid Avenue between Naranja Street and Imperial Ave.
- Prioritize pre-design funding for the Skatepark community project in Chollas Community near Gompers Park.
- Fund protected bikeways Federal Blvd from 47th to Euclid Protected bikeways.

District 5:

• Fund bike improvements for Pomerado Rd and foster collaboration with City of Poway.

District 6:

- Fund CIP Project # B22105: Governor Dr. West of Genesee.
- Fund bike lanes for Nobel Dr. currently a gap from Lebon Dr. to I5.
- Fund bike lanes for Regents Rd. currently a gap from Berino Ct. to Arriba.
- Restore bike lanes on Camino Santa Fe between Miramar and Carroll Rd.
- Buffered class II bike lane needed for North/South bike route in Mira Mesa.
- Restore bike lanes on Eastgate Mall.

• Restore bike lanes on Governor Dr. East of Genesee.

District 7:

- Fund CIP project: P18007 for Alvarado Canyon Road Realignment Allied Gardens/Grantville.
- Fund CIP project: S24004 for West Valley River Crossing- Mission Valley.
- Fund CIP project: B23030 for Updated crosswalk signals Linda Vista Rd/Comstock St-Linda Vista.
- Fund CIP project: S15019 and B18104 for the Continental Crosswalk on Mission Gorge Rd/Mission Gorge PI-Allied Gardens/Grantville.

District 8:

• Street Lighting Project for Logan Ave.

District 9:

- Fund the Rectangular Rapid Flashing Beacons at 45th & Landis (Transportation Unfunded Needs List #12512).
- Allocate funding to *install stop signs at 49th & Orange* near Ibarra Elementary School. Parents and residents have petitioned for stop signs to be installed at this location, citing concerns over frequent speeding and inadequate pedestrian crossings.
- Fund Pedestrian Enhancement and Safety Study for Home Ave.
- Fund Street Lights for the 805/15 Home Ave Exit.
- Activation of Transit Plaza Kiosk Stations.
- Fund Repaving of El Cajon Blvd and Orange Ave.
