NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

CITY PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Household Hazardous Waste Transfer Facility Asphalt Repairs

COMMUNITY PLAN AREA: Military Facilities **COUNCIL DISTRICT:** 6 **LOCATION:** 5161 Convoy St. San Diego, CA 92111

PROJECT DESCRIPTION: The proposed activity involves the resurfacing with asphalt, an area with an approximate size of 60 feet in length and 30 feet in width to allow for rainwater runoff. The location is the Household Hazardous Waste Transfer Facility located at 5161 Convoy St. San Diego, CA 92111.

The scope of work includes preparation of the surface area by means of scraping off a ¼ to ½ inch of the asphalt surface. This operation allows for better adhesion of the new asphalt paving material. Then, adding roughly 3 inches of new pavement down to allow for the natural runoff of rainwater. All materials from the preparation component will be removed by the contractor and sent for recycling/reuse. This activity is expected to be completed in one day.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities) and 15302 (Replacement or Reconstruction)

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Sections 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use, and 15302 (Replacement or Reconstruction) which consists of replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced; and where the exemptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
