Resignation from PAB: Ms. Taura Gentry Kelso resigned from the board effective immediately, April 17, 2025.

Motions Made:

 Unanimous acceptance of the minutes of meeting dated March 13, 2025. Lee Duran abstained from voting.

New PAB Officers:

- Mr. Tim Blood was unanimously elected as-Chair of PAB to replace Mr. Anyanetu effective the next PAB meeting in May.
- Mr. Ted Womack Jr. was unanimously elected as Vice-Chair of PAB to replace Mr. Diehl who
 declined to sit for the following year.
- Mr. Lee Duran was unanimously re-elected as Recorder and Mr. Yaw Dapaa was unanimously elected as Parliamentarian replacing Ms. Gentry Kelso.
- Review of San Diego Police Department Annual Report: Unanimous acceptance of the draft PAB recommendations related to the Annual Report posted to the Agenda with the following amendments:
 - o Add information on KPI recommendation.
 - Include Smart Street Lights to the "Technology Specific Recommendation" header.
 - Rewrite the final paragraphs of recommendations for "All other technologies".
- Review of San Diego Fire Department Annual Report: Unanimous acceptance of the draft PAB
 recommendations related to the Annual Report posted to the Agenda as rewritten. Based on the
 Annual Surveillance Report for UAS and feedback and additions to the use policy offered by the
 SDFD, the PAB affirms its recommendation for the UAS technology with the indicated modifications
 to its current Surveillance Use Policy.

The modification was considered necessary as the SDFD acknowledged that certain data obtained from lifeguards was shared with federal law enforcement. This was in violation of its use policy. Two amendments were proposed by SDFD and accepted by PAB.

The PAB Annual Report recommendations will be forwarded to the San Diego City Council representative.

Other Matters Discussed and of Note:

Interns were used by PAB to research the use of KPIs by other Cities across the west in their surveillance technology oversight. The results of this research by the interns are due in the near term and will be analyzed by the PAB subcommittees.

There was significant discussion on adopting additional technologies to help improve the community experience with the PAB meetings. Certain ideas included putting the meetings on other social media channels such as YouTube, etc.

The meeting adjourned at 7:30 pm.
