1) Canyonside Tennis Center Expansion Project Status Update

- Completed the Preliminary Review with the City Development Services Department (DSD) for the Canyonside Expansion Project. Two major project issues were resolved:

- Stormwater Department approved relocation of the maintenance access area to the east parking lot to accommodate construction of the eastern tennis court.
- Public Utilities Department approved construction of the two western tennis courts upon issuance of an EMRA permit and related conditions such as pipe inspections. The next step is to initiate the Site Development Permit process which requires a high precision survey of the proposed construction sites, preliminary site drawings, and interaction with multiple city department reviewers.

2) Council Policy 700-42 – Community Recreation Group Policy Update

- Combining Area Committees for CP I & CP II.
- A working committee was created to draft an updated 700-42 policy, but that work was delayed due to a lawsuit. The process on how to form boards was modified and now the working committee is ready to start working again to re-draft 700-42.
