While not designed by Lareau, they are even more rare and the very last standing cottages from circa 1910, built as part of the Theosophical Society's Lomaland community — a spiritual and educational center led by Madame Katherine Tingley that helped shape early Point Loma. These cottages housed students and faculty of Lomaland and form a rare surviving link to a time when this area was envisioned as a utopian campus by the sea, are historically significant and deserving of preservation.

I saw the article and contacted Maggie Aleksic, who was quoted in the report submitted in 2022 and asked if there was an update which is also attached and shows that the Lab providing services for the USDA.The Sykes dedication to wildlife health and the impact that the Sykes Family Molecular Diagnostics Lab at the Beckman Center has continued to have a significant role in studies pertaining to wildlife including domestic birds, elephants, killer whales, cheetahs, fish and other animals. Some that have been recently covered in the news with bird flu routinely topics of discussion. Charles and Shirley Sykes understood the significance and impacts wildlife diagnostics made in the prevention and health of worldwide bird and animal populations and the Lab continues to serve and benefit wildlife worldwide as shown by the report attached. The Lab was started in 1999 and continues to make an impact today.Pease consider the implications and impacts of the Lab since it was initiated by the Sykes.
