### A. Balboa Park Experience Plan

*For the past three years, the Balboa Park Cultural Partnership and its experience design consultant have been working to develop a comprehensive Experience Plan for the Balboa Park Cultural District. This Experience Plan will focus on ensuring that everyone visiting Balboa Park can enjoy a truly boundless selection of Arts and Culture experiences and that the guest experience in general is heightened.*

*Presentation discussed cultural partnership within Balboa Park, indicating that over 100 nonprofits work with Balboa Park, partnerships are used to advocate for arts and culture, and provide a model to the city. Organization is in support of arts & culture because it is important for the community and makes the city money. Goals include improving the experience of park visitors, increasing arts and culture community engagements, looking at the experience of the whole park and connecting items, highlighting arts & culture communities, adding a stage that small groups can EASILY use without city permitting, conducting a survey of experience, make sure cultural area by museums is managed differently, keep cultural ideas in mind, keep Kumeyaay people in mind, strengthen mobility solutions, and ensure park reflects all of San Diego. Balboa Park Explorer Card - organization wants to make sure people have access to this card, so they work with nonprofits and currently have 15,000 plus free cards out there.*
