Detective Sergeant Lawrence “Skip” Cahill Day

WHEREAS, Detective Sergeant Lawrence “Skip” Cahill has served the City of San Diego with extraordinary distinction, steadfast dedication, and unwavering courage for more than 38 years, leaving a profound and lasting legacy on the safety, security, and well-being of our community; and

WHEREAS, Detective Sergeant Cahill began his illustrious career with the San Diego Police Department upon graduating from the 108th San Diego Police Academy, beginning in the Southeastern Division where he quickly earned the respect of colleagues and the trust of the community through his tireless commitment to public safety and service; and

WHEREAS, Detective Sergeant Cahill was selected in June 1991 to serve as a Canine Officer—a prestigious assignment in which he excelled for eight years, strengthening departmental operations and enhancing the effectiveness of law enforcement efforts throughout the city; and

WHEREAS, Detective Sergeant Cahill transitioned in October 1999 to the Traffic Division, where he dedicated over a decade to ensuring the safety and order of San Diego’s roadways, serving the public with diligence, professionalism, and an unwavering sense of duty; and

WHEREAS, Detective Sergeant Cahill, upon his promotion to the rank of Sergeant in October 2011, continued his exemplary service in the San Diego Police Department’s Southern Division, and in 2015 took on a critical leadership role as Detective Sergeant in the Court Liaison Unit, where he ensured seamless coordination between law enforcement and the judicial system with integrity and precision; and

WHEREAS, Detective Sergeant Cahill, throughout nearly four decades of devoted service, has earned three Commanding Officer Citations for consistently going above and beyond the call of duty, exemplifying the highest ideals of the San Diego Police Department and setting a shining example of outstanding leadership, honorable character, and unwavering commitment to protecting the people of San Diego; NOW, THEREFORE,

BE IT PROCLAIMED, by the Council of the City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby proclaim June 5, 2025 to be “Detective Sergeant Lawrence ‘Skip’ Cahill Day” in the City of San Diego.
