## **STAFF/RANGER'S REPORT** – Rob Wheeler

- Ranger staff have been taking advantage of the cool weather and repairing damaged trails and bridges in areas of West Fortuna and Cowles Mountain including monthly volunteer events with members of the community.
- Rangers have also worked with volunteers and the Foundation to acquire and plant over 200 native plants in the Grasslands and East Fortuna Staging Areas

### **FOUNDATION REPORT** – Cynthia Cornelius

- City council has accepted the Foundations 53 acres purchased bringing the total to 108 acres acquired for MTRP
- RECON is continuing to work with the invasive brush removal in the park and is doing a second pass after invasives have resprouted
- Kickoff meeting with RECON and City staff over removal of the water primrose in Kumeyaay Lake and Old Mission Dam
- Getting closer to a final template for the review of interpretive signs in the park and content of signs that will be placed on Oak Grove
- Field trips for the school year and wrapping up and summer camp is started June 2<sup>nd</sup>
- Photo contest opening reception is the evening of May 22<sup>nd</sup>
- Hiring a new position for Education and Outreach Coordinator as well as Camp Counselor and Camp Aids for summer camp

303. Oak Grove Loop Trail Resurfacing Project Update – Rob Wheeler, Senior Park Ranger, MTRP

- We are waiting for approval from the Dept of Finance to move forward with ordering the materials from the vendors we've obtained quotes from
- Once approved we hope to begin the project as soon as possible.

- No timeline updates from last meeting
- Staff requested \$170k from the regional park improvement fund for the project and was heard an approved at the CNS committee last month and should go to City Council for approvement in May

**305.** Stowe Trail Ad-hoc Subcommittee Update – Kevin Loomis, Chair

- County task order is nearing approval which is needed for the Dept of the Navy to complete their federal endangered species act and national historic preservation act requirements which will support CEQA and NEPA requirements
- Kevin to meet with County Environmental Planner on Thursday
- Boundaries have been set
