## **DIRECTOR'S REPORT**

Michael Prinz, Development Services Department -

"The last Planning Commission hearing was held on May 1st. The Commission heard the proposed amendments to the Accessory Dwelling Unit and Junior Accessory Dwelling Unit Regulations of the San Diego Municipal Code and Local Coastal Program. The Commission voted unanimously 5 to 0, with one abstention and one recusal, to recommend to the City Council an approval of City staff's proposed amendments with a recommendation to establish a two-story height limit and request that staff present different options to the City Council regarding development scale, including but not limited to, a unit cap or a cap that includes an alternative to floor area ratio to the zone or a minimum size. The City Council hearing on the proposed ADU Amendments is scheduled for Monday, June 16th at 2 PM.

As a reminder, Planning Commission hearings will be transitioning to our new hearing room at the Development Services office, to be located at 7650 Mission Valley Road. This will occur at the end of July. The first scheduled Planning Commission hearing to be held at the Mission Valley hearing room will be July 31st. I will include this reminder in the Director's report at each meeting prior to our move to the Mission Valley office. DSD's move to the new facility is occurring in phases between now and the end of July. I will continue to provide additional information about when the building will be open to the public. Thank you."
