## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

**PROJECT NAME:** Special Event Permit - Coca Cola Holocreater Experience **COMMUNITY PLAN AREA:** Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** 333 FIRST AVENUE - Green Space

**PROJECT DESCRIPTION:** A Park Use Permit to allow the use of City-owned property, utilization of the green space area on the corner of First Avenue and J Street, with three J Street parking spaces, for an activation production that would occur on July 24, 2025, through July 27, 2025, and would include the temporary use of temporary structures, fencing and/or barriers, portable restrooms, and a generator. Noise associated with the event would occur from July 21, 2025, at 7 AM to July 27, 2025, at 11:55 PM. Set up would occur from 7 AM to 8 PM on July 21-23, 2025. The four-day event would occur from 10:30 AM to 7 PM on July 24-26, 2025, and from 11 AM until 4 PM on July 27, 2025. Dismantling would occur on July 27, 2025, from 4 PM to 11:55 PM. The estimated number of attendees would be 3,200.

No road closures associated with this event.

There would be street parking closures associated with this event and would include three spots next to the event on 1<sup>st</sup> Avenue (east-side curb), and the bike lane on J Street, from 12 AM on June 21, 2025, until 11 PM on June 27, 2025.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
