Chairman Metcalf called for review and approval of the April 10, 2025 draft minutes. Ish Khan made the motion to approve as presented, Michael Vinson seconded the motion and the motion was carried unanimously.

#### PUBLIC SAFETY

#### Monthly SDPD Issues Report - Officer John Briggs, Community Relations Officer

-NW division Restructure, SDPD's FY 2026 Budget request, and training and staffing projections. Officer Briggs commented on the terrific turnout at the budget meeting and expressed his appreciation for the community support. Officer Briggs reported that there have been no recent home burglaries, but continue to deal with issues with traffic due to construction and E Bikes. Ron Sellemi commented on the City options of alternative budget cuts and willingness to help the Mayor find additional cuts. He also commented on the disappointing failure of the Mayor to show up for the budget meeting. Michael Vinson also commented on the history of efforts to improve staffing levels which are dismal and facing the preposterous idea that there is room to cut in a region that is already under staffed.

#### DMM FSC SUBCOMMITTEE

-Beta Website. Derek Reeves expressed his appreciation for Lisa Ross and the beautiful job she did on the FSC website. Lisa Ross commented that it should be viewed and tested and would appreciate any feedback. Ish Khan will assist Derek Reeves in securing the contact information for the Meadows HOA. One of the first projects that Derek Reeves wants to work on is bringing green containers to the neighborhoods and have residents set aside a day to clear out the brush surrounding their homes and fill the green containers. Derek Reeves also noted that he has contracted with Danny Greer, a retired firefighter, to prepare a detailed report on his residence and will report back after the project. Ish Khan commented that the Fire Department offers a free evaluations. Ish Khan will find out more about how to access these services and report such to Derek Reeves. Joaquin is working with Paul Metcalf on how to legally gain access with a right of access permit to the restricted open space areas that need fuel reduction management. Lisa Ross noted that there are times during the year that the MSCP allows for removal of invasive foliage. Wendy Poyhonen commented on the positive response for a situation off of Lavandula. She also commented on the need for Toll Brothers project to get involved with clearance. Ron Sellemi suggested that we invite the Toll Brothers HOA board members to the next DMMCPB meeting. It was also commented that the Alta Del Mar HOA needs to get involved. Ron Sellemi committed on the work and support of The Preserve HOA especially for the brush management of the additional twenty five feet of the one hundred feet as permitted. Lisa Ross commented that Friends of PQ Canyon has a "right of access permit".
