# NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**LOCATION:** 6050 Beaumont Avenue, San Diego, CA 92037

**PROJECT DESCRIPTION:** Public Service Easement Vacation and Coastal Development Permit to vacate a sewer easement within a parcel with an existing single-dwelling unit at 6050 Beaumont Ave. The 0.21-acre site is located in the Residential Single-Unit (RS-1-7) Base Zone, Coastal (Non-Appealable-2) Overlay Zone, Coastal Height Limit Overlay Zone, and Transit Area Overlay Zone, within the La Jolla Community Plan Area and Council District 1. This development is within Coastal Overlay Zone. **LEGAL DESCRIPTION:** APN 357-172-02-00.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego Development Services Department

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15305, Minor Alterations in Land Use Limitations.

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15305, Minor Alterations to Land Use Limitations. This exemption allows for minor alterations in land use limitations in areas with an average slope of less than 20%, which does not result in any changes in land use or density, and where the exceptions listed in Section 15300.2 would not apply. The project involves an easement vacation for a sewer line running through a residential parcel underneath an existing single-dwelling unit and garage. The sewer line was abandoned and plugged in 2012 when a new sewer main was installed in the Beaumont Avenue public right of way. No further development is proposed. This project is consistent with these requirements, and the exceptions listed in Section 15300.2 do not apply. **The site is not included on any list compiled pursuant to Government Code Section 65962.5 for hazardous waste sites.**

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal. Please include the project number on the memo line of the check.
