Coastal Development Permit, Site Development Permit and Multi-Habitat Planning Area Boundary Line Adjustment to construct a new 16,251-square-foot, two-story single-dwelling unit over a two-level subterranean basement, accessory structure and pool on a vacant 0.77-acre lot located at 2072 Via Casa Alta in the RS-1-1 zone, the Coastal Height Limit Overlay Zone, the Coastal Overlay Zone (Non-Appealable), Environmentally Sensitive Lands (sensitive biological resources and steep hillsides), and the Multiple Habitat Planning Area in the La Jolla Community Plan and Local Coastal Program Land Use Plan.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. Those participating virtually may NOT cede time to others participating in person or virtually.

**Written Materials:** Instead of submitting materials as an attachment to the <u>webform</u>, you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

## **Late-Arriving Materials:**

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3<sup>rd</sup> Floor, San Diego, CA. 92101.
