■ SANDAG

1. The Purple Line project proposal was discussed. It would serve as a North-South connection and be elevated in many areas. Currently, it is in the conceptual study phase. The project is expected to take 13 years to build and will require tunneling. Ridership is projected to be between 23,000 and 29,000 daily riders. The Linda Vista Planning Group (LVPG) emphasized the need to shift the Purple Line to areas more aligned with the freeway.

■ PureWater

1. Marissa is the liaison for the Pump Station Project and provided an update on new traffic control measures. A full closure of Friars Road is scheduled for March 1st, with westbound lanes reopening while eastbound lanes will be closed. Signage can be placed as needed.

2. Octavio Chiquet provided an update on the Alvarado Road piping project and noted that additional work will also take place on SeaWorld Drive. The expected timeline for this work extends to mid-2026.

i The Linda Vista Planning Group (LVPG) had comments regarding the Morena project and would like to know how long it will be affected. Additionally, it was noted that a different contractor is handling this project compared to the Pure Water project. LVPG would like to schedule a meeting to receive an update on the project's completion date.
