## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## CITY PLANNING DEPARTMENT

**PROJECT NAME/NUMBER:** Roof Replacement and Solar Installation (Urban Corp)

**COMMUNITY PLAN AREA:** Midway

COUNCIL DISTRICT: 2

**LOCATION:** 3127 Jefferson Street, San Diego, CA 92110

**PROJECT DESCRIPTION:** The proposed project involves installing new roofs and solar photovoltaic

systems on two campus buildings.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**ENVIRONMENTAL DETERMINATION:** Statutorily exempt from CEQA pursuant to CEQA section 21080.35, as added by Senate Bill 226. In addition, this activity is categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee.

## STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 21080.35, as added by Senate Bill 226, which exempts the installation of a solar energy system, including all associated equipment, on the roof of an existing building or at an existing parking lot; Section 15301 (Existing Facilities) which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. The exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; as to the exception for hazardous materials, there are locations listed on GeoTracker and EnviroStor within 1,000 feet of the project area. While these locations are listed, there are no environmental cases of known hazardous material contamination that would be disturbed which would otherwise preclude use of a CEQA exemption pursuant to Section 65962.5 of the Government Code. Any future project(s) associated with this activity will be subject to CEQA review at a future date pursuant to CEQA Guidelines Section 15004 which provides direction to lead agencies on the appropriate timing for environmental review.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
