Rule	Change	Reason
1.2 - Place	Change the meeting location from the Council Chambers at 202 C Street to the hearing room at the new DSD building: 7650 Mission Valley Road.	Planning Commission will meet at 7650 Mission Valley Road beginning July 31, 2025.
1.3 – Change of Time and Place	Remove language related to changes in time and location of meetings being scheduled for agenda items "considered to be of importance and high value."	This change clarifies that time and place can be changed for any reason, provided public notice procedures are followed.
