# Highlight of Changes

Rule	Change	Reason
1.2 - Place	<p>Change the meeting location from the Council Chambers at 202 C Street to the hearing room at the new DSD building:</p> <p>7650 Mission Valley Road.</p>	Planning Commission will meet at 7650 Mission Valley Road beginning July 31, 2025.
1.3 – Change of Time and Place	<p>Remove language related to changes in time and location of meetings being scheduled for agenda items “considered to be of importance and high value.”</p>	This change clarifies that time and place can be changed for any reason, provided public notice procedures are followed.

# Highlight of Changes

Rule	Change	Reason
2.2 – Order of Business	Modify #3, Consent Agenda	Current Planning Commission practice does not include consent items on the regular agenda. The Commission decides at each meeting whether to place agenda items on consent.
	Modify #4, from Approval of the Agenda to the Approval of Minutes,	
	Delete #7, Items Pulled From Consent Agenda	
	Renumber the remaining items	The Planning Commission decides at each meeting whether to approve previous meeting minutes or approve as corrected.
Throughout	Other minor edits and typographic changes adjusted throughout
