Plan to Achieve

Morgner Construction Management has reviewed the February 2025 Skilled and Trained Workforce Monthly Compliance Report and acknowledges that the percentages for both apprentice graduates and workers with the required on-the-job experience did not meet the mandated minimum thresholds. This variance is primarily due to the specialized, non-recurring nature of the work performed during this reporting period, which required limited workforce deployment and highly specific skill sets not commonly represented within the available apprentice graduate labor pool.

However, Morgner will resume covered work in quarters 3 and 4 2025, with a focus on general labor activities. We anticipate a significant increase in both Journeyman and Apprentice hours during this time, which will enhance the total reported labor hours and allow us to make substantial progress toward meeting the skilled and trained workforce requirements.

Moving forward, we are committed to identifying scopes of work that support greater utilization of apprentice graduates and will continue to engage with labor partners and trade programs to expand access to qualified workers. Morgner remains dedicated to complying with program goals and will make every effort to increase participation rates in future reporting periods.
