ITEM 1: T-MOBILE CHATSWORTH - PROJECT NO. 1115214

Staff: Ian Heacox City Council District: 2 Plan Area: Peninsula

Conditional Use Permit to continue the operation of an existing rooftop T-Mobile Wireless Communication Facility (WCF) located at 3704 Tennyson Street in the RM-3-7 (Residential – Multiple Unit) zone, the Coastal Height Limit Overlay Zone, and the FAA Part 77 Noticing Area for San Diego International Airport and North Island Naval Air Station within the Peninsula Community Plan. The WCF consists of seven (7) panel antennas and six (6) Remote Radio Units (RRUs). Additionally, the project includes ancillary equipment for support to the WCF, including three (3) equipment cabinets. The 200-square-foot equipment enclosure is located on the roof. This project does not include any modifications or new equipment.

This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act (CEQA).

#### ITEM 2: NOLITA HALL LIVE ENTERTAINMENT - PROJECT NO. 1125013

Staff: Saba Raisesmaili City Council District: 3 Plan Area: Downtown

Conditional Use Permit to allow indoor live entertainment at Nolita Hall, located at 2305 India Street on the 5,804-square-foot property at the northeast corner of India Street and West Juniper Street, within the Mixed Commercial land use district of the Centre City Planned District, a Transit Priority Area, and the Little Italy neighborhood of the Downtown Community Plan.

The Project is consistent with the previously certified <u>Downtown Final</u> <u>Environmental Impact Report</u> as amended and no additional environmental document is required under the California Environmental Quality Act (CEQA).

#### ITEM 3: 625 WRELTON DRIVE - PROJECT NO. 1109781

Staff: Sarah Hatinen City Council District: 1 Plan Area: La Jolla

Amendment to Coastal Development Permit No. 91-0400 for a remodel and addition to an existing 3,027-square-foot two-story single-dwelling unit, roof deck, penthouse, and detached accessory structure. The additions consist of a 186-square-foot first-floor addition, a 1,676-square-foot second-floor addition, a 115-square-foot penthouse, and decks located at 625 Wrelton Drive. The 0.29-acre site is in the RS-1-7 zone, the Coastal Overlay Zone (Appealable), the Coastal Height Limit Overlay Zone, the First Public Roadway, the Parking Impact Overlay Zone, the Transit Area Overlay Zone, and a Transit Priority Area within the La Jolla Community Plan.

This project was determined to be categorically exempt pursuant to Section 15332 (In-Fill Development) of the California Environmental Quality Act (CEQA).

### ITEM 4: WATER BAR ROOF DECK - PROJECT NO. 1116682

Staff: Travis Cleveland City Council District: 2 Plan Area: Pacific Beach

Coastal Development Permit for a 3,785-square-foot proposed new roof deck addition with bar and seating area for an existing two-story restaurant at 4325 Ocean Boulevard. The 0.33-acre site is in the CV-1-2 zone, the Coastal Overlay Zone (Appealable Area), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, the Transit Area Overlay Zone, a Sustainable Development Area, a Parking Standards Transit Priority Area, and a Transit Priority Area within the Pacific Beach Community Plan and Local Coastal Program.

This project was determined to be categorically exempt pursuant to Section 15332 (In-fill Development) of the California Environmental Quality Act (CEQA).
