NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

CITY PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Consent to Sublease Brown Field Municipal Airport – Hangar P-8

COMMUNITY PLAN AREA: Otay Mesa

COUNCIL DISTRICT: 8

LOCATION: Hangar P-8 (1424 Continental Street, San Diego, California 92154)

PROJECT DESCRIPTION: Under Section 4.2 of the previously approved Lease between the City of San Diego (City) and Air Center San Diego LLC (Lessee) relating to approximately 18.655 acres within Brown Field Municipal Airport (Premises), the Lessee requires the City's consent prior to entering into any sublease of the Premises. The Lessee is requesting consent from the City to sublease a portion of the leased Premises known as Hangar P-8, consisting of an aircraft hangar containing approximately 1,200 square feet, located at 1424 Continental Street, San Diego, California 92154 (Sublease Premises), to Scott Henry (Subtenant) for aircraft storage and for no other purpose or use.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:

The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section 15301 (Existing Facilities) which exempts the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use; and where the exceptions to the exemptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked before or on the final date of the appeal.

Bring the fully completed appeal application <u>DS-3031</u> (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
