

# FINAL NOTICE: IMMEDIATE ACTION REQUIRED



If you believe your property was incorrectly identified as ineligible to receive City collection services, visit **sandiego.gov/trash** to review the eligibility criteria and file an Appeal.

If you are receiving this notice and are already enrolled with a Franchise Hauler, please email documentation with proof of enrollment (e.g. a copy of the agreement or invoice) to wasteservice@sandiego.gov to avoid violations.

Our records indicate that you have not enrolled your property identified below in the required trash, recycling and organic waste collection service with a City-authorized Franchise Hauler by your required deadline. This final notice follows multiple mailers and reminders.

#### **CONSEQUENCES FOR NONCOMPLIANCE**

Failure to comply in a timely manner will result in:

- Notice of Violations issued to the property owner by the City.
- Citations with fines assessed for each violation.

# **REQUIRED ACTION**

Your property is **not eligible** for City of San Diego service per the City's Municipal Code and Waste Management Regulation. This is your **final notice** to establish the required trash, recycling and organic waste recycling service with one of the five City-authorized Franchise Haulers (EDCO, Republic Services, UWS, Ware Disposal, WM).

### **HOW TO AVOID VIOLATIONS AND FINES**

# 1. Contact the Franchise Haulers now to determine which provider best meets your property's waste collection needs.

- Please note that not all haulers are currently active in all areas of the City, and services offered by each hauler may vary by hauler and by property type. Preference for one type of service over another (e.g., preference for cart service rather than dumpster service) does not exempt transition requirements or deadlines (i.e., properties offered only dumpster service must still enroll with a Franchise Hauler).
- If your property is part of a larger complex, please coordinate with your HOA to select a service provider. Groups of neighboring properties required to transition that are not part of an HOA may also find it advantageous to coordinate together to secure a private Franchise Hauler.

# 2. Select one Franchise Hauler to provide trash, recycling and organic waste recycling services to your property.

## 3. Confirm your service start date with your Franchise Hauler.

• Franchise Haulers will coordinate the delivery of your new containers and remove City containers during that process. If you find that your Franchise Hauler containers were delivered but your City containers were not removed, please contact us at 619-533-4440 or wasteservice@sandiego.gov for assistance.

# This is your final opportunity to comply before the City proceeds with violations and subsequent fines.

The fines will help the City recover the costs it is incurring to provide service to transitioning customers ineligible for City-provided service, which are otherwise being incurred by the City's General Fund.

# Why am I being offered dumpsters instead of carts

Haulers may recommend dumpsters due to property layout, route coverage, or waste volume. Dumpsters can be more cost-effective and provide greater capacity, lockable lids and better security in shared areas. Below will display the space savings dumpsters offer in comparison to traditional cart service.

### What if my neighbors and I don't have an HOA to manage service?

If your multi-home complex doesn't have an HOA, you may consider using a waste broker. Brokers don't collect trash but can coordinate group service, billing, rates and schedules with haulers. Property owners are still responsible for setting up the required trash, recycling and organic waste collection. Visit **sandiego.gov/csg** to review recycling requirements. The City does not endorse or recommend any specific broker.

# What if no Franchise Hauler will service my property?

If you've contacted all five haulers and all declined, email or call us with documentation of your outreach (emails, denial notices or call records with dates/times) from all five haulers. Note: Disagreeing with a hauler's container type (e.g., being offered a dumpster) or rate does not count as a denial of service. The City does not set rates or assign haulers, but we are working with haulers to address service gaps.

We appreciate your attention to this important transition. Act now to avoid potential violations with fines and to protect public health, safety and our environment.
