NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Bella Vita

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: India St from Grape St to Cedar St., Fir St from Kettner Blvd to Columbia St

PROJECT DESCRIPTION: Special Event Permit for San Diego's Italian Chalk & Wine Festival in Little Italy, the Bella Vita on October 18 & 19, 2025, on the five blocks of India Street from Grape Street to Cedar Street, and Fir Street from Kettner Blvd. to Columbia Street. The event would include chalk art, a stage, entertainment, sound amplification, generators, food sampling, alcohol, tents, fenced in beer garden, fencing and/or barriers, canopies, tables, chairs, portable restrooms, and recycling/trash containers. Noise associated with the event would occur from 2 AM on October 18, 2025, until 11:55 PM on October 19, 2025. Set up would occur on October 18, 2025, from 2 AM to 11 AM. The two-day event would occur on October 18, 2025, from 11 AM to 6 PM, October 19, 2025, from 11 AM to 5 PM. And dismantling would occur on October 19, 2025, 5 PM to 11:55 PM.

The following roads would be closed from October 18, 2025, at 2 AM to October 19, 2025, at 11:59 PM:

- India St. from Grape St. to Cedar St.
- W. Fir Street from Kettner Blvd to Columbia St.
- Date Street from India St. to Kettner Blvd.
- Additional parking closures from cul de sac on Fir Street, West of Kettner

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.

Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
