NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Wolters Kluwer

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: 5th Ave between J St. & K St. / 4th Ave. between J and K St./ K St between 4th and 6th

PROJECT DESCRIPTION: Special Event Permit for private corporate event on October 22, 2025, on 5th Ave between J St. & K St. / 4th Ave. between J and K St./ K St between 4th and 6th Avenues. The event would include décor, lighting, entertainment, sound amplification, a stage, temporary structures, generators, onsite food preparation, alcohol, tents, fencing and/or barriers, canopies, tables, chairs, portable restrooms, and recycling/trash containers. Noise associated with the event would occur from 6 AM on October 22, 2025, until 6 AM on October 23, 2025. Set up would occur on October 22, 2025, from 6 AM to 6 PM. The event would occur on October 22, 2025, from 6 PM to 10 PM. And dismantling would occur on from 10 PM on October 22, 2025, until 6 AM on October 23, 2025.

The following roads, street parking, and bike lane would be closed from October 22, 2025, at 6 AM to October 23, 2025, at 6 AM:

- 5th Avenue between J and K Street both sides
- Additional parking closures:
 - K Street between 4th and 6th both sides
 - J Street between 4th and 6th south sides
 - 4th St. between J and K Ave. east side
 - Bike Lane - J Street between 4th and 6th

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2. Bring the fully completed appeal application DS-3031 (including grounds for appeal and supporting documentation) to the City Administration Building— Public Information Counter (Open 8:00am to 5:00pm Monday through Friday excluding City approved holidays), 1st Floor Lobby, located at 202 C Street, San Diego, CA 92101, by 5:00pm on the last day of the appeal period. The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.

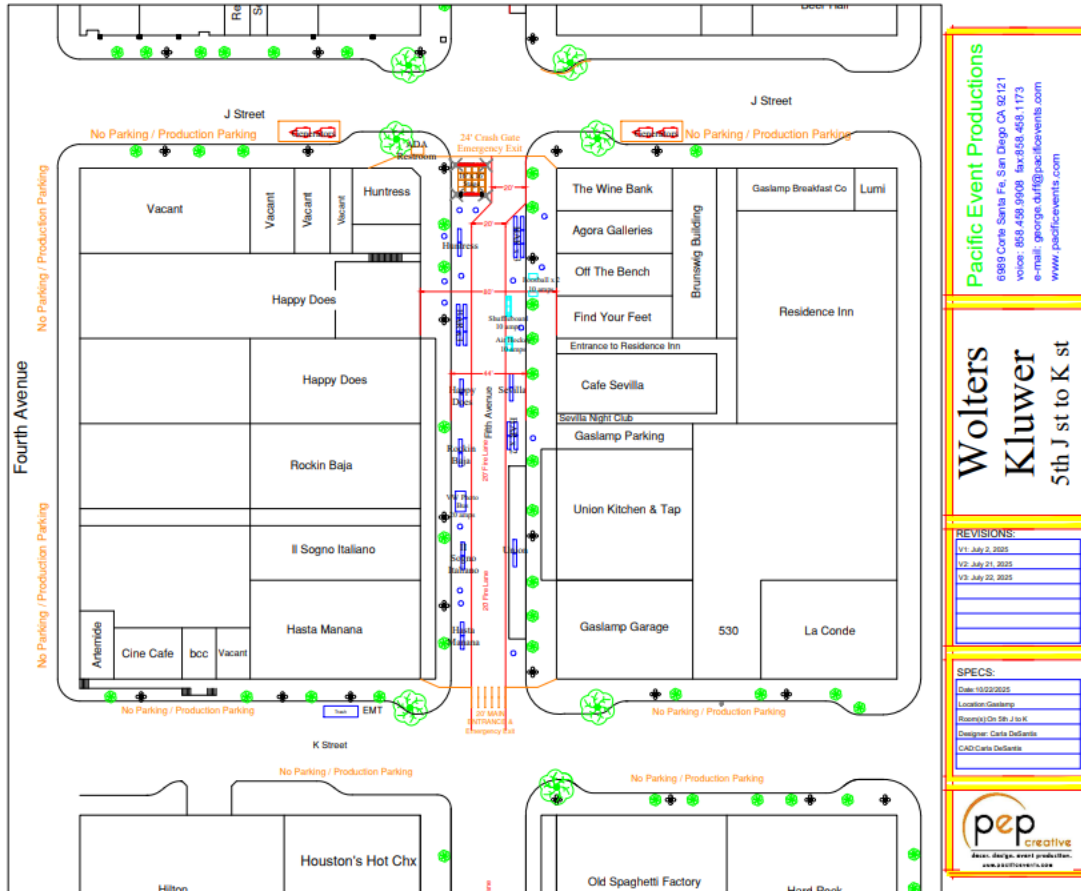
