## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - 3rd Annual Dia De Muertos En Barrio Logan

**COMMUNITY PLAN AREA:** Barrio Logan

**COUNCIL DISTRICT: 8** 

**LOCATION:** Logan Ave, S. Evan St., Sampson St., 26<sup>th</sup> St., Sicard St. (see attached map)

**PROJECT DESCRIPTION:** A Special Event Permit for the Dia De Muertos Celebration in Barrio Logan event that would take place in Barrio Logan (see attached map) on October 26, 2025. The event would include a market, workshops, art installations, a stage, music, entertainment, sound amplification, generators, food, onsite food preparation, food trucks, vendors, canopies, tables, chairs, trash/recycling containers, and portable restrooms. Noise associated with the event would occur on October 24, 2025, from 8 AM to October 27, 2025, at 5 PM. Set up would occur on October 24, 2025, from 8 AM to 5 PM, and on October 26, 2025, from 6 AM to 12 PM. The event would occur on October 26, 2025, from 12 PM to 7 PM, and dismantling would occur from 7 PM to 9 PM on October 26, 2025, and from 8 AM to 5 PM and on October 27, 2025.

Road and parking closures associated with the event would occur from October 26, 2025, and would include the following:

- 2060 block of Logan Ave to the 2030 block (Culdesac) of Logan Ave. from 6 AM to 9 PM
- S. Evans St. from the intersection of National Ave. to end of Culdesac of S. Evans St. from 6 AM to 9 PM
- Sampson St. from the intersection at National Ave. to the intersection of Sampson St and Kearny Ave. from 3:04 AM to 9 PM
- S. 26th St. from its conjunction with Logan Ave. to the intersection at National Ave. from 6 AM to 9 PM
- Sicard St. from National Ave. to intersection of S. 26th St. from 6 AM to 9 PM

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
