**Subject: Approval of Sigma Corporation Mechanical Joint Restraint**

This is in reference to your application in which you requested the City of San Diego (City) to evaluate the Sigma Corporation products PV-LOK PWM Machine Serrated Clamping Rings for C900 Pipe Joint Restraints, ONE-LOK SLCE Mechanical Joint restraint for PVC Pipe, SLCEH Bell Joint Harness for PVC Pipe, PWP Bell Joint Harness for PVC Pipe, ONE-LOK SLDE Mechanical Joint restraint for Ductile Iron Pipe for approval and addition to the City's Water Approved Materials List.

The City has completed the evaluation and determined that adequate product information has been presented to approve the Sigma Corporation PV-LOK PWM Machine Serrated Clamping Rings for C900 Pipe Joint Restraints, ONE-LOK SLCE Mechanical Joint restraint for PVC Pipe, SLCEH Bell Joint Harness for PVC Pipe, PWP Bell Joint Harness for PVC Pipe, ONE-LOK SLDE Mechanical Joint restraint for Ductile Iron Pipe.

The acceptance and approval of Sigma Corporation Products is contingent on the following conditions:

- 1) The Sigma Corporation Mechanical Joint Restraint products shall be manufactured at 700 Goldman Drive, Cream Ridge, NJ 08514
- 2) Sigma Corporation shall notify the City in advance of any changes in the product, change in ownership of the manufacturing plant, or change in the location of the manufacturing plant.
- 3) Sigma Corporation shall provide application/installation procedures for the products to ensure they meet the current Standard Specifications for Public Works Construction (Greenbook) and the current City's Whitebook. The installer shall meet the specification

conditions required for the proper installation of the product as specified by Sigma Corporation or any of Sigma Corporation's authorized suppliers.

- 4) Any unilateral action by Sigma Corporation without seeking prior consultation and agreement from the City regarding the above-mentioned conditions and limitations shall constitute a breach of agreement, resulting in the removal of Sigma Corporation products from the City's Approved Materials List.

Congratulations on your success in being included on the City's Water Approved Materials List.
