 - a. Karleen volunteered to replace Lorna Zukas who resigned. Daniele motioned to approve, Denise 2nd, 6 ayes, no nays.
- 2. Support for expanding the parks golf course fence on the 52nd street & Orange Ave area Tabled since Dave Lee is absent.

• It was noted that an event by the College Area Community Council at the United Domestic Workers Hall honored fire fighters from the Montezuma fire and Josh Cummings for community work.

STAFF REPORTS

- 1. Council District 9 Francisco Vargas Peralta
 - a. Francisco no longer listed on City website. It was noted that some people have removed listings due to attacks on social media. Follow up with Dave to verify who is the current representative for Colina.
- SDPD Community Relations Officer, Joshua Cummings absent, no report
- 3. Area Manager Dave Lee (via Fernando)
 - Park clean up project and pool parking lot resurfacing to take place at Colina.
 Date of work is unknown.
 - b. It was reported that Pendleton bid has been awarded, work expected in August. It was not clear if this was for the solar panels, or the park.
 - c. Tubman will be under construction starting December this year for modernization, 2/3 of the field will be closed for 3 years.
 - d. Montezuma Construction Documents (design)is under way, Frank Hunt Lee is PM.
 - e. Language Academy no report
 - f. Rolando Park Elementary It was asked whether the site visit for the arborist was scheduled. Lynn thinks is has already been done. 11 of the 17 trees are reported dead.
 - g. North Chollas, Sunshine, Fay, Ibarra no reports
 - h. Oak Park in discussion for arborist event
 - i. Street Soccer USA is connecting with SDUSD to build a field at Mann outside of the Joint Use Agreement, replacing two asphalt basketball courts. Per Karleen it will be Futsal (indoor) size.
 - j. Hardy closed for 3 years for modernization
 - k. Wightman fencing seems to be helping
 - 1. Federal Blvd (triangle) Groundworks working on street vacation, storing equipment. Project is \$3 million short.
- 4. Recreation Center Director Fernando Jumillas
 - a. Just started futsal, 5 teams total
 - b. In week 7 of 10 or summer camp averaging 20 kids per week.
 - c. No free lunches from Colina, they are provided by City Heights, for campers only.
 - d. About 150 attendees at summer movie (Colina). Per Lynn Pendleton movie is scheduled for August 16; need to check if it will conflict with construction mobilization.
 - e. Per Lynn Rolando Elementary parking lot is closed for construction and is impacting park use. Construction crew mobilized a couple weeks ago, broke water main.
 - f. Daniele asked about homeless at Colina...per Fernando no change, maybe a little less. Sue noted trash has increased.
 - g. Daniele: will futsal restriping happen this year (Colina). Fernando noted that futsal restriping will happen at Colina after Friday league ends mid to late August and will include crack repair /surface improvements and the SDFC logo. Daniele requested to see the logo before the work is done.

- h. One Colina basketball basket is broken.
- i. Daniele requested to follow up with Dave on the special event noted last time that was charging for parking.
- 5. Pool Manager Ashley Soto Jimenez Absent, no updates on pool, summer running smoothly

 - e. A GDP amendment for Hollywood Park through Azalea will be proposing disk golf as a trial. It was asked whether parts of the course could be used for soccer.
