#### **Inclusive Public Engagement Guide Background and Overview**

The creation of an Inclusive Public Engagement Guide (Guide) was identified as an implementation action within the <u>Parks Master Plan</u> and <u>Climate Resilient SD</u> Plans adopted by City Council in 2021. The City of San Diego will create a strategy for City staff to use to promote inclusive public engagement and community participation in plans, programs, projects, and policies, particularly for people who have experienced barriers to public participation. The Guide will serve as the foundation for City employees to implement a meaningful public engagement program that considers input from community members representative of the population's demographics so that City decisions ultimately improve San Diegans' quality of life.

#### **Focused Discussion Group Overview**

The City established a Focused Discussion Group (FDG) of community members to discuss their lived experiences and perspectives on community engagement to inform the Inclusive Public Engagement Guide. The FDG is comprised of 10 diverse members who met the selection criteria and are motivated by inclusive public engagement.

This group met six times from April through June 2023. Members were selected based on a combination of their community involvement interests and objectives for representation across San Diego communities and city demographics. Members received a \$40 stipend per meeting for time, transportation, and other costs related to participation in the group.

The City of San Diego's main objective for conducting community engagement with the Focused Discussion Group was to understand from community members what makes public engagement meaningful and accessible for them, so that the City strategy for inclusive public involvement is successful.

#### **Focused Discussion Group Selection Process**

On March 16, 2023, the City of San Diego published the application to join the FDG on the project website in English and Spanish. An email with attached flyers in English and Spanish inviting applicants for the Focused Discussion Group was sent to Council offices, local community-based organizations and leaders, business, advocacy and tribal groups, community planning groups and City boards, commissions and working groups, asking that they share the Focused Discussion Group application opportunity with their networks. The City also promoted the opportunity on social media and with people signed up for the City Planning newsletter. The application period was open for three weeks from March 16 to April 4, 2023. The City received 115 completed applications over the three-week application period.

Focused Discussion Group members were selected based on a set of criteria set by the City to help ensure a range of perspectives were reflected in this engagement process. Applications were tabulated in an anonymized format (without names and contact information) to show applicants' geography (community they live in), community involvement experience (including previous participation in the workshops and community meetings), age range, income range, and living arrangements. The anonymized tabulation was used to select members who created a roster reflecting a range of neighborhoods, community involvement experience, ages, income, and living arrangements.

The membership of the group was limited to 10 people to ensure focused conversations could take place around a variety of topics relevant to community engagement throughout the six meetings, with the opportunity to hear from all selected participants.
