ITEM 1: 991 SCOTT STREET – PROJECT NO. 1111697

Coastal Development Permit for the remodel of an existing 3,500-square-foot (SF) two-story single-dwelling unit with a detached 417 SF garage, the removal of existing 648 SF and the conversion of existing 725 SF into an accessory dwelling unit (ADU) on the first floor, the addition of 1,042 SF consisting of 66 SF on the first floor, 40 SF on the second floor, the construction of a 936 SF third floor, the conversion of an existing garage into a carport, and associated site improvements. The 0.12-acre project site is located at 991 Scott Street in the Residential – Single Unit (RS-1-7) zone, the Coastal Overlay Zone (Appealable, First Public Roadway), the Coastal Height Limit Overlay Zone, the Airport Land Use Compatibility Overlay Zone for Naval Air Station (NAS) North Island (Review Area 2) and San Diego International Airport (SDIA, Review Area 2), the Parking Impact Overlay Zone, a Parking Standards Transit Priority Area, a Transit Priority Area, and the Federal Aviation Administration (FAA) Part 77 Noticing Area for NAS North Island and SDIA within the Peninsula Community Plan and Local Coastal Program Land Use Plan. This development is within the Coastal Overlay Zone and the application was deemed complete on May 9, 2024.

This project was determined to be categorically exempt pursuant to Section 15301(e), Existing Facilities and Section 15303, New Construction or Conversion of Small Structures, of the California Environmental Quality Act (CEQA).

HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1st Floor, San Diego, CA 92108.
