ITEM 1: VERIZON-MIRAMAR RANCH NORTH – PROJECT NO. 1114673

City Council District: 5

Plan Area: Miramar Ranch North

Conditional Use Permit and Neighborhood Development Permit to modify and continue the use of an existing Wireless Communication Facility (WCF) consisting of the removal of 15 antennas and installation of 12 façade mounted antennas behind Fiber-Reinforced Plastic (FRP) boxes on an existing water tank, and an existing 458 square foot equipment enclosure located on the ground. The site is located at 11485 Weatherhill Way in the RS-1-14 zone of the Miramar Ranch North Community Plan.

This project was determined to be categorically exempt pursuant to Section 15301, Existing Facilities and Section 15302, Replacement or Reconstruction of the California Environmental Quality Act (CEQA).

ITEM 2: 4606 MISSION GORGE PLACE – PROJECT NO. 1124190

Plan Area: Navajo

Conditional Use Permit to allow sales of alcoholic beverages at an existing 2,802-square-foot retail store located at 4606 Mission Gorge Place. The 4.47-acre site is in the CC-3-8 zone, the Airport Land Use Compatibility Overlay Zone, the Airport Influence Area for Montgomery Field (Review Area 2), the FAA Part 77 Noticing Area for Montgomery Field, the Community Plan Implementation Overlay Zone (Type A), a Parking Standards Transit Priority Area, a Transit Priority Area, and a Special Flood Hazard Area within the Navajo Community Plan.

This project was determined to be categorically exempt pursuant to Section 15301(Existing Facilities) of the California Environmental Quality Act (CEQA).

ITEM 3: 5090 SHOREHAM PLACE – PROJECT NO. 1124729

Plan Area: University

Tentative Map to create 36 commercial condominiums within two existing buildings at 5080 and 5090 Shoreham Place. No new development is proposed. The 0.13-acre site is in the CO-3-3 zone within the University Community Plan.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1st Floor, San Diego, CA 92108. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.
