- 3. Security gates are not being closed at night in Marian Bear Memorial Park due to the city budget and cuts to the security contract in charge of closing the gates. Ranger Steve plans to get another security contract in the fiscal year beginning July 1.
- 4. The Regents East parking lot is being used by construction crews to stage their equipment in exchange for filling gravel dips that develop over time.

303. Wildlife and Vegetation Matters

1. Steve saw a rattlesnake in Marian Bear and they have been sighted by the sink hole. Some chickens have been found in the Regents East parking lot. Native annuals are blooming.

304. Current Events

- 1. The Pure Water Project could be done in several months.
- 2. Del Cover repaired a broken bridge railing and added a third railing to reinforce the structure.
