201. Fiscal Year 2026 Mission Bay Park Improvement Funds – Proposed Reallocation

Should the Mission Bay Park Improvement Fund Oversight Committee approve the recommendation to reallocate \$500,000 of Mission Bay Park Improvement Funds to the following project:

- Mission Beach Lifeguard Station, CIP# L25001- \$500,000

Funding will come from the following project:

- \$500,000 from Mission Bay Park Improvements, CIP# AGF00004. There is currently additional audited revenue that has been collected from Fiscal Year 2025. After this allocation, there will still be over \$3.2 million in reserves in the annual allocation

This project provides a phased approach to replacing the Mission Beach Lifeguard Station, located at 3141 Ocean Front Walk. Phase 1 provides for emergency action to conduct a structural assessment, evaluate repair options, and implement repairs for the lifeguard station to allow time to plan for replacing the station. Phase 2 provides for temporary facilities to provide necessary public services prior to and during construction of a permanent replacement for the existing lifeguard station. Phase 3 will provide for the design and construction of a new lifeguard station, including demolition of existing facilities
