- a. There is an output goal with the annual plan that accompanies the funding distribution.
- b. Mixed use hasn't been included so far as far they know.
- c. Ultimately, the management would not be the commission's responsibility.
- d. Developers will hold the majority of the risk for completing a project, but funding could still fall short.

 - a. Housing Impact Fee from commercial development and Pay In-Lieu fees from residential development.

 - a. There's a notice of funding available to provide gap funding.
- h. Bob Mikloski asked about what the income level to qualify for the programs.
 - a. Funds must be used for very low, low, and median income.

- j. Resident mentioned that there is a 10 year waiting list.
 - a. For the voucher system, there is a limited amount for the vouchers and their effectiveness has been reduced due to increasing prices. New programs are being looked at to replace the system.
