### III. Action and Informational Items (6:15-6:55 p.m.)

- a. **Action Item 1 (6:15-6:30):** Implementation of Transit Signal Priority (TSP) along key North Park bus corridors including El Cajon Boulevard, University Avenue, 30th Street, and Park Boulevard. Action is to review proposed endorsement letter to the city on this topic and make recommendation to the full board.
- b. **Action Item 2 (6:30-6:45):** The need for traffic calming on Arnold Street between Landis Street and Upas Street was brought up by a community member at the 12 August PF&T subcommittee meeting due to an accident and several near misses in this area of the community. Additionally the city's Traffic Calming Guidelines Manual was highlighted by board member Holden Leslie-Bole:

- c. **Information Item 1 (6:45-6:50):** The North Park Main Street Mobility Committee is teaming with AARP at their next meeting on **23 September 1:00-2:00 pm** to collaborate on solution recommendations for three items that were also noted in the NPPC Capital Improvement Project list: 1) Ray and North Park Way Intersection, 2) Upas and 30th Street Intersection, and 3) Thorn and Redwood Art Work. - d. **Information Item 2 (6:50-6:55):** Launch of the City of San Diego Community Recreation Needs Assessment.
