#### **CALL TO ORDER**

Chairperson Molly Chase called the meeting to order at 6:06 p.m. Johnny Chou read the statement listed on the agenda that this Committee meeting will be conducted pursuant to the provisions of the California Executive Order 29–20 which suspends certain requirements of the Ralph M. Brown Act.

#### **APPROVAL OF MINUTES October 7, 2021**

A motion was made by Mr. Eddy and seconded by Ms. Soares to approve the October 7, 2021 meeting minutes. The motion carried (8-0-2) Dang Nguyen and Sarah Dawe abstained

#### **NON- AGENDA PUBLIC COMMENT**

Daniele Laman HPR International Cottages thanked City staff for fixing all the broken windows at the HPR cottages. Working with City staff to add new lights at the cottages. An Active shooter training will be coming to Balboa Park Institutions will be coming soon.

Paul Kruger – Resident in Talmage, commented on the number of vendors in the Prado, referenced the December 14 council agenda item, suggesting limiting the number of vendors in the park. Urged the BPC to endorse sensible restrictions to vendors.

<u>CHAIRPERSON'S REPORT</u> – Chairperson Molly Chase thanked nonprofit partners and Christina's staff for the explainer sessions and the new members who participated. Looking for additional ways to engage with partners in addition to the member updates that they are

providing at the committee meetings to find out more regularly what they are doing outside of the park through different opportunities. Highly recommends the Vicky Estrada's upcoming briefing session on the Balboa Master Plan. Upcoming items: Design review, currently evaluating the proposal internally and will bring this item for future consideration. Mobility, starting a conversation with the mobility director Alyssa Muto and Parks and Recreation staff. They will be presenting mobility concepts for the park from the feedback in January. A Workshop item from the City's independent budget analyst will be moved to a future meeting. Wants to make sure that this committee has a handle on the City's budget process and begin to tackle the funded and unfunded list of the park and how the committee can participate in advocating for our projects in the upcoming budget cycle. Recognized the passing of Jim Dawe a dedicated park servant. Jim loved our library's system. He was a board member of the Park Conservancy and would like to honor and remember him for his dedication to our City.

#### **STAFF REPORT** -

City Council Third District – Codi Vierra reported the street vending draft ordinance will be coming forward in December and they have taken input from constituents and visitors of the park. The Council member was pleased to participate in the Balboa Park Cultural Partnership board meeting. Where topics discussed included Arts and Cultural funding and the council member reaffirmed his commitment to the penny for the arts and other arts and cultural funding. The IBA presentation was moved, however they are starting to receive outreach from folks regarding the council member priorities which are due in January.

Assistant Deputy Director – Christina Chadwick reported that Council President Campbell recently announced her intent to bring forward a legislative change to address the street vending ordinance. For everyone that is interested in the street vendor ordinance we will provide information to you as we receive it and the timeline for this is December The comic—con exterior restoration is complete, thanks to the committee of 100 for helping with a new paint on comic—con and in anticipation of the museum opening in weeks. The Botanical Building restoration phase one; Parks and Recreation Department together with Engineering and Capital Projects is now working internally to prepare for phase one construction with contractors. The details on park impacts and the construction will start coming to you publicly on an ongoing basis beginning now and continuing through the completion of the project in spring 2023. A presentation will be in the coming months to share more details. The Botanical Building will close January 1, 2022 and the City will begin to relocate the plants to the Balboa Park Nursery. Currently in the Botanical Building is the Fall display and Forever Balboa Park is planning its holiday display of Poinsettias to be installed in mid—December and will be on display until January 1, 2022.

District Manager – Johnny Chou reported the recreation staff from Municipal Gym and Balboa Park Activity Center did a Halloween Drive through event at Morley Field on October 22. There about 100 participants that drove through the event. Taste of December Nights be held from Friday, December 3 to Sunday December 5. The event will utilize all 3 lots at Inspiration Point. The event runs from 11am – 10 pm each day. The Notice of Right to Appeal for Exploratory Evaluation of Balboa Park Municipal Gym has been posted.

<u>BALBOA PARK NON-PROFIT PARTNER UPDATES</u> (Time allotted to each speaker is determined by the Chair; however, comments are limited to no more than three (3) minutes)

Forever Balboa Park – Jackie Higgins reported that the Botanical Building Phase 1 is moving forward, thanks to Parks and Recreation, the City Engineering Group and all City employees. Forever Balboa Park is continuing to work on Phase 2 and finalizing the scope for phase 2 for

the restoration of the Botanical Building. Park wide signage and wayfinding initiative did take a pause during the pandemic, however, with that pause it gave an opportunity to be more inclusive with the signage and to include bilingual options, the implementation of phase 1 will be in the summer of 2022. Shout out to all volunteer programs, Park Ambassadors, Volunteers, Garden Stewards, Tree Stewards. They donated over two thousand hours of work in September which equates to over sixty-five thousand dollars of service hours for Balboa Park. There are tree planting coming up in the Fall and newly planted trees are updated in the tree plotter inventory. The full inventory includes over seventeen thousand trees in Balboa Park. Tree Stewards and tree Steward maintenance parties maintain over eight hundred trees in Balboa Park and there is a success rate of eighty-six percent. This is the thirty-fifth annual of the Poinsettia display in the Botanical Building. Currently collaborating with SDG&E for the third annual Plant it Forward event.

Balboa Park Cultural Partnership – Peter Comiskey congratulated the House of Korea for the Korea Day on October 23<sup>rd</sup>. Currently has an RFP in the experience plan for the Balboa Park Cultural District. November 12<sup>th</sup> RFP's will be due and hopes to announce the finalist at the next meeting. They are not doing this alone but with over a hundred stakeholders engaged including a highly representative advisory board of representatives throughout the county. Each year the Cultural Partnership advocates for funding for the arts and culture, they are fighting to ensure that funding returns to at least pre-pandemic levels. Thanks to the Council Member for their support and looks forward for the support of the committee. The Cultural Partnership is starting to plan the trustees connected event which encourage everyone to join as one and celebrate the park. It is yet to be scheduled but likely to be held in the Mingei Museum in early March.

Balboa Park Online Collaborative - No report.

Committee of 100 – Roger Showley reported the new exterior paint of the Comic Con Museum. He showed the winner of the winner of the AIGA poster contest. There were 17 entries for the contests. Introduced the "IDEA District+" concept.

Save Starlight – Steve Stopper reported more supporters and board members have come on.

- Mr. Parzen inquired about what research has been made about the Brandagees. He did not want anything bad to turn up in the future.

**501. Parks and Recreation Fee Schedule Update.** Presenter: Shelly Stowell, Deputy Director, Parks and Recreation Department and Sarah Erazo, Program Manager, Parks and Recreation Department.

Public Comment: Ms. Johnston, Ms. Cheatom, Mr. Marsh, Mr. Eddy, Mr. Comiskey, Mr. Showley and Mr. Rene Smith

- Ms. Johnston was inquiring if there were any changes to renting out parking lots and if charges for traffic control and staff cost are included.
- Ms. Cheatom was inquiring if the service cost at Mt. Hope had gone up. She also asked for clarification on the volleyball leagues charges.
- Mr. Marsh inquired if there would be any reductions. Wanted to see if there was any
  consideration for at base mobility providers (scooters) or other revenue generating
  opportunities.
- Mr. Eddy inquired if adjustment are being made going forward and the review should be looked at every few years.
- Mr. Comiskey commented about golf carts charges and usage in Balboa Park.
- Mr. Showley inquired if the fees are per person or group. He also wanted to know if all the rental fees go to the General Fund.
- Mr. Smith wanted to have more time to review items. He commented about cost recovery of user groups and how it works.

**502. Balboa Park Quick Build Roundabout.** Presenters: Philip Rust, Associate Engineer, City of and San Diego

Public Comment: Mr. Eddy, Mr. Marsh, Ms. Johnston, Mr. Blackson, Ms. Chase, Ms. Higgins, Mr. Showley and Mr. Smith

- Mr. Eddy inquired about the striping of the roundabout and why is the project restricted to the current footprint.
- Mr. Marsh commented without knowing the bigger picture it is hard to understand the total safety of the area. He also inquired about the landscaping and if there has been any other consideration for traffic calming. Want to see if information of the project could be placed by the intersection to inform community members.
- Ms. Johnston commented she really hopes it fits in with everything. She also mentioned most roundabouts have something in the middle of them.
- Mr. Blackson commented he loved it. The roundabouts are great. He supports the quick build and the bike lanes.
- Ms. Chase agreed with Mr. Blackson's comments.
- Ms. Higgins inquired about plantings in the roundabout.
- Mr. Showley commented there should be more done to beatify the roundabout.
- Mr. Smith inquire if the footprint size of the project and the drainage of the intersection. He also inquired about adding sidewalks to the project.









In 1914, 325 were planted in Balboa Park . . . just outside of the Rose Garden . . . . The Park bought 175, and I donated 150.

This group was planted in honor of Mr. and Mrs. Brandegee . . . .








= San Jose Hesper Palms




