  - o The office can work with Caltrans to help address encampment issues around the freeways.

- Alex Southard shared information regarding upcoming activities.
- For FY2026, SBEP was partially funded at \$750,000. Each BID manager was notified of their SBEP allocation, San Ysidro's allocation was \$14,887.26.
- EDD is working with the Mayor's office to distribute "Know Your Rights" immigration information to businesses through Business Walks. - EDD is excited to share that the Capacity Building Grant Program is now live on our website until September 5<sup>th</sup> <u>sandiego.gov/capacity-building-grant</u>.
